ASSISTANT SUPERINTENDENT
IN DELHI PRISONS DEPARTMENT (POST CODE-38/13)

1. The DSSSB vide its advertisement No. 02/2013 with closing date 02.08.2013, had advertised 35 vacancies (UR-19, OBC-09, SC-05, ST-02; out of which 04 vacancies were reserved for EXSM) for the post of Assistant Superintendent in Delhi Prisons Department in the pay scale of Rs. 5200-20200 having Grade pay of 2800/- (Group-C Jail cadre).
2. The Board had conducted the written examination on 09.03.2014 for the post of Assistant Superintendent under postcode 38/13. On the basis of the written examination the candidates were shortlisted to appear for PET, which was qualifying in nature. After conducting the Physical Endurance test (PET-I, PET-II & PET-III) in respect of shortlisted candidates from 16.03.2015 to 22.03.2015; then from 12.07.2016 to 13.07.2016 and also on 16.02.2018 34 candidates who qualified the PET were nominated to the post of Assistant Superintendent under post code 38/13 vide result notice No. 342 dated 15.10.2015 and subsequent result notice No. 350 dated 18.12.2015, result notice No. 367 dated 14.01.2016, result notice No. 415 dated 28.07.2016, result notice No. 511 dated 16.05.2017, result notice No. 679 dated 30.06.2018 and result notice No. 733 dated 14.11.2018
3. In view of unfilled vacancies including vacancies arise due to cancellation of candidature of 11 candidates by user department, 373 candidates were shortlisted for appearing in PET-IV for the post of Assistant Superintendent in Delhi Prisons Department under postcode 38/13 vide notice 705 dated 23.8.2018 and addendum dated 31.08.2018.
4. The PET-IV was conducted from 18.09.2018 to 20.09.2018, wherein out of 373 shortlisted candidates only 87 appeared for PET. Further from the 87 present candidates only 20 could qualify the PET. The result status of PET-IV was declared vide notice number 732 dated 14.11.2018. Simultaneously, 20 candidates who have qualified the PET were provisionally shortlisted to upload e-dossiers up to 3.12.2018

5. Ld CAT vide its interim order dated 9.2.2017 in OA No 35/2017 in the matter of Kuldeep Kadyan vs DSSSB has directed to keep one post under as pending, accordingly one post of UR category is kept as pending.

6. Ld CAT order interim order dated 9.1.2017 in OA No 4312/16 in the matter of Pawan vs DSSSB has directed to keep one post under SC category as pending; accordingly one post is kept as pending.

7. Sh Arvind Kumar Tomar(13000906) was earlier selected to the post of Assistant Superintendent under postcode 38/13 vide result notice number 415 dated 28.07.2016, his dossier was returned by the Prisons Department vide their letter dated 13.7.2017 as the candidate has not reported to join the post. In view of representation dated 04.06.2018 of Arvind Kumar Tomar(13000906) to send him the joining letter to the post, one vacancy in UR category has been withheld for obtaining the report from the user department.

8. On the basis of the written examination held on 09.03.2014 and on qualifying the PET, after preliminary scrutiny of the candidature of candidates as per the provisions of the statutory Recruitment Rules for the post in respect of the educational qualification and the terms and conditions of the advertisement, the following candidates are provisionally selected to the post of Assistant Superintendent, subject to satisfaction in regard to any defect or deformity (including bow legged, knocked knees, flat feet etc.) which would render candidate ineligible for recruitment as per the requirement of the RRs:

13. The selection of the above **07** Candidates shall be further subject to the thorough verification of the candidature of the candidate by the User Department including the identity of the candidate. **Further the user department shall arrange for checking of defect or deformity (including bow legged, knocked knees, flat feet etc.) of the candidates as per the requirement of the RRs, which has not been done during PET-IV.**

14. The candidature of the candidate is liable to be cancelled by the User Department, in case candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the post or any other genuine reason. The decision of the User Department/appointing authority regarding the eligibility of the candidate shall be the final and binding on the candidate.

15. The User department shall check the eligibility of the reservation benefit, if any. Further, if applicable User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates.

16. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application forms vis-à-vis the original documents including the Degree. Further, the appointing authority shall verify these documents and satisfy itself about the authenticity of documents/certificates before finally appointing the candidates.

17. Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.

18. Further on account of lowering of cutoff marks for shortlisting the candidates to appear in PET-IV the selection of the following candidate who was earlier selected in OBC category vide result notice number 367 dated 14.01.2016; 511 dated 16.5.2017 and 679 dated 30.3.2018 is now shifted to UR category

22. The candidate having roll number 13002884 in ST category was found not qualified as per the essential educational qualification as on cutoff date a such his candidature has been rejected and not kept in the select waitlist panel.
