SUPPLEMENTARY RESULT NOTICE NO: 926 FIRE OPERATOR, POST CODE- 18/19 IN DELHI FIRE SERVICE

- 1. The DSSSB vide its advertisement No. **04/19** dated 24/09/2019 had advertised total 706 (EWS-21, UR-190, OBC-115, SC-309, ST-71) vacancies for the post of **Fire Operator in Delhi Fire Service, Post Code 18/19** with closing date as 06/11/2019. Physical Endurance Test was held w.e.f. 11.01.2020 to 22.02.2020, Online written Examination was held on 20.04.2021 & 22.04.2021 & Skill Test (Driving) was held w.e.f 31.05.2022 to 01.08.2022.
- 2. The marks of Physical Endurance Test were declared on the website of the Board vide notice dated 05.04.2021, the marks of online written examination were declared on the website of the Board vide notice dated 09.07.2021. Further, marks of Skill Test (Driving) were declared on the website of the Board vide notice dated 28.12.2022.
- 3. Further, taking into consideration the RRS, selection criteria and as per decision of Delhi Fire Service department vide letter dated 29.11.2022 of Chief Fire Officer, the final result has been prepared consisting 100 marks of PET, 100 marks of Written Test and 100 marks of Skill Test (Driving). Each module i.e. Physical Endurance Test, Written Test and Skill Test (Driving) has been given equivalent weightage while preparing the merit list/final result. The written test which was taken for 200 marks have been converted/scaled down proportionately to 100 marks for equivalent weightage with other modules. Hence, merit/final result has been prepared based on total marks obtained out of 300 [i.e 100 marks each for Physical Endurance Test, Written Test & Skill Test (Driving)].
- 4. Accordingly, a total 1099 candidates who qualified each module i.e Physical Endurance Test, Written Test and Skill Test (Driving) were shortlisted as per their merit for uploading of edossier in OARS module w.e.f 05.01.2023 to 19.01.2023. The Result of the post of Fire Operator, Post code -18/19 was declared vide Main Result Notice No. 897 dated 09/02/2023 wherein 697 candidates were provisionally nominated and 81 Candidates were nominated in waiting panel.
- 5. Now, the User Department i.e. Delhi Fire Service vide letter dated 17/01/2024 has returned 76 dossiers (UR-16, EWS-01, OBC-55, SC-02, ST-02) of the candidates after cancellation of their candidature who failed to join their duties in the User Department. The user department has further requested to provide 35 candidates under OBC category from the waiting panel. As the waiting panel for the post code -18/19 was valid upto 08.02.2024 and the requisition for substitute candidates received before expiry of waiting panel. Accordingly, 35 candidates (OBC-35) from waiting/reserve panel have been provisionally nominated for the post of Fire Operator, Post code -18/19 in Delhi Fire Service.
- 6. The result of the Supplementary candidates has been processed purely on the basis of marks obtained by the candidates in Physical Endurance Test, Online Written Examination & Skill Test (Driving) and also claims made by the candidates in their online application forms of

- the Post of Fire Operator under Post Code -18/19 in Delhi Fire Service. The Board has not undertaken scrutiny of documents uploaded in the e-dossiers at this stage, as per Board's resolution/decision dated 14.07.2022. The eligibility as per Recruitment Rules and other terms and conditions as specified in the advertisement number 04/19 and relaxations as per rules in respect of educational qualification, age experience, etc., shall be scrutinized/verified by the User Department for determining eligibility of the candidates for the post code -18/19 as on cut off date i.e. 06.11.2019, before issuance of offer of appointment to the post.
- 7. Accordingly, in continuation of Result Notice No. 897 dated 09.02.2023, the candidates, as detailed below, are also provisionally nominated purely on the basis of marks obtained by the candidate in the basis of marks secured in the Physical Endurance Test, online written examination & Skill Test (Driving) and considering other relaxations, if any claimed by the candidate in their online application forms of the post code 18/19 for the post of Fire Operator, Post Code-18/19 in Delhi Fire Service. The Board has not undertaken scrutiny of documents uploaded in the e-dossier at this stage, as per Board's resolution/decision dated 14/07/2022. The eligibility as per Recruitment Rules and other terms and conditions as specified in the Advertisement No. 04/19 and relaxations as per rules in respect of educational qualifications, age, experience, etc. shall be scrutinized / verified by the User Department for determining eligibility of the candidates for the post code- 18/19 as on cutoff date 06.11.2019 before issuance of offer of appointment to the post:-

8. The provisional nomination of the above **35 candidates under OBC Category** is on the basis of their claims in their application form shall be subject to thorough verification of their candidature by the user department including the identity of the candidates as per Services Department circular No. F16(3)/2007/S-III/1756-1763 dated 02/08/2021.

- 9. The provisional nomination of the above 35 candidates under OBC category shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidates is liable to be cancelled by the User Department also, in case the candidates are found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as laid down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.
- 10. The user department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department shall verify the genuineness of the Caste Certificates furnished by the candidate prior to issuing offer of appointment to the candidate. The Competent Authority of the user department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny /correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
- 11. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the Competent Authority prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidate is fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
- 12. The User Department shall also get the SC/ST/OBC/PH/ExSM/etc. certificates verified from the Issuing authority. Further, if applicable, User Department shall also verify the genuineness of the caste certificates furnished by the candidates prior to issuing offer of appointment to the candidates. In case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DoPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2009 and O.M. No. 36033/1/2013-Estt. (Res) dated 27.05.2013 & 13.09.2017.
- 13. The User Department shall also get the EWS certificates verified from the Issuing authority. Further, the User Department shall also verify the veracity of the Income and

asset certificate submitted by the candidate through the certificate issuing authority as per instruction of DoPT O.M. No. 36039/1/2019-Estt (Res) dated 31.01.2019.

- 14. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application form and e-dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential Certificates as per instructions issued by Govt. of India in this regard vide MHA O.M. No. 2/29/54-RPS, 19-11-54.
- 15. The user department shall ensure that the appointment made is in conformity with DoPT guidelines and instructions of Govt. issued from time to time.
- 16. The category wise marks obtained by the last selected candidate has been given as under:-

- 17. The result process for the above post code stands closed in all respect. Waiting panel was valid for a period of one year from the date of declaration of result i.e. upto 08/02/2024 as per Main Result Notice No. 897 dated 09/02/2023 which has been expired. The said result is declared against returned dossiers by the User Department which received in the Board well before expiry of waiting panel.
- 18. Mere inclusion of name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.
- 19. The above result for the post of Fire Operator under Post Code -18/19 in Delhi Fire Service is subject to outcome of pending courts cases related to this post codes, if any, in various courts.
- 20. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any detected at any stage or arising due to court cases, if any.
