FINAL RESULT NOTICE No.1461 LIBRARIAN IN DIRECTORATE OF EDUCATION UNDER POST CODE 163/2007

- 1. This result Notice is in continuation to the result Notice No 743 dated 05.12.2018 for the post of Librarian, post code 163/07 in Dte of Education, Govt of Delhi. The DSSSB vide its advertisement number 07/2007 with closing date 29/10/2007 had advertised 39 vacancies (UR-20, OBC-15, SC-03 & ST-01 including OH-01 and VH-01) for the post of Librarian in Directorate of Education under Post code 163/07.
- 2. The marks of Part-II examination of the 14 candidates having roll number -1710468, 1711104, 1711320, 1713029, 1713069, 1810014, 1810046, 1810080, 16310001, 16310008, 16310037, 16310038, 16310045, 16310047 were not declared as their Part-II examination answer sheets for postcode 163/07 were not available/traceable in the Board. The preference of claim for postcode 163/07 was called from these candidates vides Notice No. 741 dated 16/11/2018 and Public Notice dated 26/11/2018 and also through individual letters dated 30/11/2018 to these 14 candidates to prefer their claim for the post of Librarian under Post Code 163/07.
- 3. In response to aforesaid Public Notices 08 candidates having roll number 1711104, 1713029, 1810046, 16310008, 16310037, 16310038, 16310045 and 16310047 submitted preference for the Post Code 163/07 and after obtaining their consent/under taking for re-examination, re-examination of Part II (Descriptive) was taken by the Board on 03/11/2019. The candidature of 06 candidates having roll no. 1710468, 1711320, 1713069, 1810014, 1810080 & 16310001 has not been considered for post code 163/07.
- 4. In the re-examination of Part II (Descriptive) held on 03/11/2019 out of 08 candidates, 05 candidates having roll no. 4350000004 (1711104), 4350000008 (16310047), 4350000006 (16310008), 4350000001 (1810046) and 4350000005 (16310037) appeared in the said examination. The minimum qualifying marks for nomination for the post are 45% in UR category and 35% for other reserved categories. The normalized marks obtained by these 05 candidates in Part II (descriptive) Examination under post code 163/07 is as under:

5. Vide Public Notice dated 26.06.2019, on website of the Board and in leading News Papers, twelve candidates and vide Public Notice dated 12/05/2023 Twenty

candidates were requested to provide copy of application form, admit card, documents related to their educational qualification, proof of residence, two photo graphs, caste certificate and other documents as per the relevant advertisement, through e-mail at helpdesk-dsssb@nic.in. Out of these 32 candidates response/documents was received from 14 candidates only. The following 18 candidates did not submit the documents as sought from them and therefore their candidature has not been considered in Post Code 163/07:

- 6. The result has been processed purely on the basis of marks obtained by the candidates in the Part-II examination. At this stage, as per the Board's resolution dated 14/07/2022, the Board has not undertaken scrutiny of any documents in the dossiers and other terms and conditions of recruitment notified by the Board in the advertisement of the post code 163/07. Therefore, the User Department must ensure the eligibility of the candidate as per the RRs and the correctness of the experience certificates/Computer certificates furnished by the candidate at their own level. The eligibility as per Recruitment Rules and other terms and conditions as specified in the advertisement no. 07/2007 and relaxations as per rules in respect of educational qualifications, experience, age etc. shall be scrutinized/verified by the User Department for determining eligibility of the candidate for the post code 163/07 as on cutoff date 29/10/2007 before issuance of offer of appointment to the post.
- 7. The following candidates are provisionally nominated to the post of Librarian in Directorate of Education, Govt of Delhi, under Post code 163/07:

8. As the Board had conducted a combined exam for the post of Librarian for the post codes 17/07 (Dte of Education), 182/07 (H&FW), 163/07 (Dte of Education) & 30/08 (MAIDS) on 18/01/2009, as such the candidates who have already been selected in postcodes 17/07, 182/07 and 30/08 have not been again reconsidered for nomination in postcode 163/07.

- 9. The nomination of the above 31 Candidates (UR-17, OBC-10, SC-03 and OH-01(UR)) shall be further subject to the thorough verification of the candidature of the candidate by the User Department including the identity of the candidate. All these nominations are purely provisional subject to admissibility of the experience details /Computer Certificates furnished by the candidate in reference to the provisions as prescribed in the RRs for the post by the User Department in view of the Hon'ble High Court judgment dated 25.09.2017 in WPC No. 6131/17 in the matter of DSSSB & Ors vs Vijeta Kundu & Ors.
- 10. DSSSB has not undertaken any veracity/scrutiny of any of the documents. Therefore User Department must ensure the eligibility of the candidate in terms of educational qualification, experience, computer knowledge etc. as per the RRs and the correctness of the certificates/Computer certificates furnished by the candidate at their own level.
- 11. The Provisionally Nomination of the above 31 Candidates (UR-17, OBC-10, SC-03 and OH-01(UR)) shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of the advertisement inviting application and subject to thorough verification of their identity with reference to their photographs, signature/handwriting, etc. on the application form, admission certificate, etc. The Candidature of the above candidates are liable to be cancelled by the user department also, in case the candidates are found not to be fulfilling the terms and conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.
- 12. The User Department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department i.e. Directorate of Education shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
- 13. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the competent authorities prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified

- in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
- 14. The User Department shall also get the SC/ST/OBC certificates verified from the issuing authority before his /her appointment. Further, in case of OBC Candidates, it may also be verified that the candidate does not belongs to creamy layer of the schedule of Govt. of India, DOPT O. M. No. 36012/22/93-Estt. (SCT) dated 08/09/1993 O. M. No. 36033/3/2004-Estt. (Res) dated 09/03/2004 and OM No. 36033/3/2004-Estt. (Res) dated 14/10/2008 and OM No. 36033/I/2013-Estt. (Res) dated 27/05/2013 and 13/05/2017.
- 15. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his/her eligibility as laid down in the Recruitment Rules and after verification of the correctness of the information furnished in the application form and the documents related to education qualification, age and other essential certificates as per Government of India instructions issued in this regards vide MHA OM No. 2/29/54-RPS, 19/11/54.
- 16. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
- 17. Mere inclusion of the name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.
- 18. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
- 19. The result is subject to the outcome of the court cases, if any, pending in various courts related to this post.
- 20. The category wise marks scored by the last candidate provisionally nominated are as under:-

- 25. The User Department, being Cadre Controlling/Appointing Authority, shall strictly follow the merit based ranking of the candidate in the main list and the waiting list.
- 26. The User Department, at its own level, will utilize the Waiting List only after exhausting the main list and after affording sufficient opportunity to the provisionally nominated candidates as per the extant guidelines issued by the GNCTD/DoPT.
- 27. The candidates in the Waiting Panel or the Balance Reserve Panel shall have no claim or right for appointment per se against the vacancies notified for the recruitment. They can only get the offer of appointment only in the event any vacancies (categorywise) arising due to non-acceptance of the offer of appointment, not joining the post after acceptance of appointment, resignation after joining, etc within one year of validity of panel.
- 28. While operating the waiting panel list, the User Department shall strictly follow instructions issued vide DoPT OM No. 36012/2/96-Estt. (Res) dated 02/07/1997, 36011/1/98-Estt. (Res) dated 01/07/1998 and 43011/4/2018-Estt. (Res) dated 04/04/2018 regarding shifting of candidates from respective reserve categories to the un-reserve category.
- 29. The User Department shall operate the waiting panel up to the number of vacancies notified under each category by the DSSSB in its advertisement and not beyond it even by taking any type of relaxation from any authority as it shall rendered the excess appointment void and illegal *Ab initio*.
- 30. As soon as validity period of the waiting panel expires and /or number of notified vacancies are filled up hence waiting panel becomes redundant, the User Department shall return the cancelled and unutilized dossiers to DSSSB with complete details/ statistics forthwith.

- 31. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
- 32. Wherever the Court has directed to not declare result without leave of the court such cases will be dealt separately, if falling in main result/proposed waiting panel list. The user department shall decide such cases subject to outcome of court case(s).
- 33. The result is subject to the outcome of the court cases, if any, pending in various courts related to this post.
