SUPPLEMENTARY RESULT NOTICE No.:- & O C WARDER MALE (POST CODE 37/2013) IN DELHI PRISON DEPARTMENT

- 1. The DSSSB vide its advertisement No. 02/2013 with closing date 02/08/213, had advertised 528 vacancies (UR-268, OBC-142, SC-79, ST-39 out of which 53 vacancies were reserved for EXSM) for the Post of Warder (Male) in Delhi Prison Department.
- 2. The Board had conducted the written examination on 02/03/2014 for the Post of Warder (Male) under Post Code 37/13. On the basis of the written examination the candidate were shortlisted to appear for PET, which was qualifying in nature. After qualifying the Physical Endurance Test (PET0I, PET-II, PET-III and PET-IV) in respect of shortlisted candidates from 16/03/2015 to 22/03/2015, and also from 01/07/2016 to 09/07/2016; on 06/05/2017 from 12/02/2018 to 14/02/2018 and 04/10/2018 to 11/10/2018, 502 candidates who qualified the PET were nominated to the post of Warder (Male) under Post Code 37/13 vide result notice no. 357 dated 29/12/2015 and subsequent result notice no. 381 dated 07/03/2016, result notice no. 382 dated 13/04/2016, result notice no. 471 dated 15/02/2017, result notice no. 523 dated 27/06/2017, result notice no. 683 dated 09/08/2018, result notice no. 775 dated 08/04/2019 and corrigendum no. 787 dated 22/05/2019.
- 3. The candidature of candidate having roll number 13007595 is still withheld for further examination.
- 4. The candidature of following 04 OBC candidates having roll no. 13030587, 13041779, 13009051 and 13040578 which were earlier kept pending now considered for selection in OBC Category in view of judgment of Hon'ble Supreme Court of India in Civil Appeal No. 1691 of 2016 arising out of SLP (C) No. 27550 of 2012 in the matter of Ram Kumar Gijroya V/s DSSSB & ANRS.
- 5. The candidature of 01 OBC Candidate having roll no. 13002451 which was earlier rejected is now considered for selection in view of judgment of Hon'ble High Court of Delhi in WP (C) No. 2074/2019 and CM No. 9688/2019 in the matter of Govt. of NCT of Delhi V/s Rishabh Mallik.
- 6. Ld. CAT vide its interim order dated 07/04/2015 in OA No. 1294/2015 in the matter of Varun Sharma V/s GNCTD has directed to keep one post pending, accordingly one post of UR Category is kept as pending.
- 7. After preliminary scrutiny of the candidature of candidates as per the provisions of the statutory Recruitment Rules for the post in respect of the educational qualifications and the terms and conditions of the advertisement on qualifying the PET, the following candidate are provisionally selected to the post of Warder (Male) as per their merit, subject to satisfaction in regard to any defect or deformity (including bow legged, knocked knees,



flat feets, etc.) to be checked by the User Department which would render candidate ineligible for recruitment as per the requirement of the RRs:-

8. User Department, i.e., Prison Department has returned 06 Dossiers (UR-05, SC-01) on the grounds that candidates have not responded/Joined the post of Warder. The dossiers have been returned before the expiry of waitlist panel. Hence the Board is declaring the result of Panel/Waitlisted Candidates as per their merit, as per details below:-

- 9. There is no candidate in Select Panel in SC as such no candidate can be nominated against retuned dossier in this Category.
- 10. The Selection of the above 09 candidates (UR-04, OBC-05) shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of the advertisement inviting application and subject to thorough verification of their identity with reference to their photographs, signature/handwriting, etc. on the application form, admission certificate, etc. The Candidature of the above candidates are liable to be cancelled by the user department also, in case the candidates are found not to be fulfilling the terms and conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his/her eligibility as laid down in the Recruitment Rules and after verification of the correctness of the information furnished in the application form and the documents related to education qualification, age and other essential certificates as per Government of India instructions issued in this regards vide MHA OM No. 2/29/54-RPS, 19/11/54.
- 11. The User Department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the

information/documents as furnished in the application forms and e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency notices in the documents of the candidate at their own level.

- 12. It is stated that the User Department i.e. Prison Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 08/09/1993 36012/22-93-Estt. (SCT) dated issued by DOPT instructions/guidelines issued from time to time by the competent authorities prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
- 13. The User Department shall also get the SC/ST/OBC certificates verified from the issuing authority before his /her appointment. Further, in case of OBC Candidates, it may also be verified that the candidate does not belongs to creamy layer of the schedule of Govt. of India, DOPT O. M. No. 36012/22/93-Estt. (SCT) dated 08/09/1993 O. M. No. 36033/3/2004-Estt. (Res) dated 09/03/2004 and OM No. 36033/3/2004-Estt. (Res) dated 14/08/2008.
- 14. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the application forms vis-a-vis the original documents. Further, the appointing authority shall verify these documents and satisfy itself about the authenticity of documents/certificates before finally appointing the candidates.
- 15. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
- 16. The selection of the candidates are subject to the outcome of the court order in the matter of Vinay Mann V/s GNCTD in OA No. 2284/2016 or other pending court case, if any.
- 17. The result process for the above post code stands closed in all respect except 01 court case candidate. Further, validity for waitlist panel of the candidates under UR & OBC Category expired on 08/07/2019.
- 18. The category wise marks scored by the last candidate provisionally nominated are as under:-
