SUPPLEMENTARY RESULT NOTICE NO. 494

SUPERVISOR, GR.II (FEMALE) IN DEPTT. OF WOMEN & CHILD DEVELOPMENT

The DSSSB vide its advertisement No.02/2014 DATED 12/12/2014 had advertised total **290 vacancies [UR-145, OBC-79, SC-44 & ST-22 including PH/OH-03, PH/VH-03 & PH/HH-03]** for the post of **Supervisor, Gr.II(Female) under Post code-212/14** in Department of Women & Child Development with closing date as **25.01.2015**. Out of 290 vacancies, 25% are reserved for Anganwari workers. Thus, the total vacancies available for direct recruitment was **(UR-109, OBC-59, SC-33 & ST-16 including PH/OH-02, PH/VH-02 and PH/HH-02)** and the reserved vacancies for Anganwari workers was **(UR-36, OBC-20, SC-11, ST-06 including PH/OH-01, PH/VH-01 & PH/HH-01)** Tier-I examination in offline examination mode was conducted on **05.03.2017**.

2. On the basis of offline examination of Tier-1 held on **05.03.2017** and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.02/2014 and RRs for the post of Supervisor, Gr.II(Female), Post Code-212/14 in Department of Women & Child Development, a total of **161 (UR-93, OBC-38, SC-23 and ST-07 including PH/OH-01)** candidates were provisionally nominated for the post of Supervisor, Gr.II(Female) **under direct recruitment quota** and **SC-01 under Anganwari worker quota** vide Result Notice **No.149** dated **06.06.2017** and the candidature of 48 candidates were kept pending for clarification and Court case candidates and the candidates whose candidature were kept pending have been directed to upload the requisite documents.

3. Thereafter, one candidate has represented to the Board regarding her eligibility on the basis of reservation benefits available to Widow/divorcee. Her representation has been considered and she was provisionally nominated vide Result Notice **No.223** dated **25.01.2018**.

4. The pending candidates, whose candidature were kept pending for want of documents, have uploaded the requisite documents. On scrutiny of the documents, it has been found that these candidates are eligible in accordance with advertisement No.02/2014 and RRs for the post of Supervisor, Gr.II(Female), Post Code-212/2014, these candidates **(OBC-05, SC-01)** were provisionally nominated vide Result Notice **No.234** dated **22/03/2018**.

5. Thereafter, the User department has returned the dossiers of 14 candidates for suitable replacement as the candidates provisionally nominated earlier have either resigned or not joined. Besides this, the result of 25% vacancies reserved for Anganwari workers were also processed.

6. On scrutiny of the documents, it has been found that 13 candidates under direct recruitment quota and 01 candidate under Anganwari worker quota are fulfilling the eligibility conditions in accordance with advertisement No.02/2014 and RRs for the post of Supervisor, Gr.II(Female), Post Code-212/14, these candidates **(UR-05, OBC-06 and SC-02)** under **direct recruitment quota** and **SC-01 candidate under Anganwari worker quota** were provisionally nominated vide Result Notice **No.259** dated **22/06/2018**.

7. In order to fill up the remaining vacancies, the candidates who were below in merit than the last candidate provisionally nominated earlier and whose candidature kept pending were considered. On scrutiny of the documents submitted by the candidates, it is found that they are eligible in accordance with advertisement No.02/2014 and RRs for the post of Supervisor, Gr.II (Female), Post Code-212/14.

8. The selection of the above candidate shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidates are liable to be cancelled by the User Department also, in case the candidates are found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as laid down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.

9. The User department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, User Department shall verify the genuineness of the Caste Certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the application forms and e-dossier vis-à-vis the original documents. The User department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User department is also requested to rectify/correct, in case any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.

10. The User department shall verify the genuineness of the Caste certificate furnished by the candidates in the light of Notification No.36012/22/93-Estt.(SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the Competent authorities prior to issuance of offer of appointment to the candidate. It is further stated that prior to appointment, the user department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC(Delhi) certificate as specified in various orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Deptt., GNCTD after thorough verification of Caste Certificate.

11. The User Department shall also get the SC/ST/OBC certificates verified from the Issuing authority. Further, if applicable, User department shall verify the genuineness of the Caste certificate furnished by the candidate prior to issuing officer of appointment to the candidates. in case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DOPT O.M. No.36012/22/93-Estt.(SCT) dated 08.09.1993, O.M. No.36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2009 and 36033/1/2013-Estt. (Res) dated 27.05.2013.

12. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application for and e dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential certificates as per Instructions issued by Govt. of India in this regard vide MHA OM No.2/29/54-RRs 19-11-54.

13. The User department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt issued from time to time.

14. Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the User department is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.

15. Further, the candidature of 01 candidate is kept pending for insufficient documents, as per details given below. She is directed to upload the pending/ requisite/applicable documents in the e dossier module within the stipulate time, i.e. from 20.8.2019 to 26-08-2019.

17. The recruitment process for the post of Supervisor, Gr.II(Female) stands closed in all respect except 18[17 vacancies (UR-05, OBC-05, SC-07) for court case candidates and 01 vacancy for want of documents] pending candidates.



18. Further, wait list/panel for the post code-212/14 stands expired on 05.06.2018, i.e. after one year from the date of declaration of result on 06/06/2017.
