Sub: Release of marks and calling of e-dossier for the post of Manager (Electrical) in DTC under Post Code 11/22

1. The DSSSB vide its advertisement no. 06/22 dated 11/04/2022 with closing date 09/05/2022 had advertised 01 UR vacancy for the Post of Manager (Electrical) in DTC under Post Code 11/22.
2. The online Tier-I Exam was held on 06/08/2022 and out of 338 candidates 100 UR candidates were shortlisted for appearing in Tier-II exam vide Notice No. 1422 dated 28/02/2023.
3. The online Tier-II written examination (Single Shift) for recruitment in respect of this post was conducted on 23/11/2023. Out of 100 candidates only 66 candidates were appeared in Tier-II exam.
4. The prorated marks obtained by 66 candidates who appeared in Tier-II written examination held on 23/11/2023 have been uploaded on Board's website. Candidates can view their marks by logging in to their account in OARS module on www.dsssonline.nic.in.
5. Based on the performance in the Tier-II examination, the candidates who have secured equal or more marks in their respective category as per details given below in the table have been provisionally shortlisted to up-load e-dossier subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application form.

6. As per examination scheme DSSSB will conduct Tier-I and Tier-II exam for the post. Tier-I exam is only qualify in nature and used for shortlisting only. Further, selection will be made on the basis of Merit/Marks obtained in Tier-II examination. Evaluation of Tier-II examination will be undertaken based on cumulative marks (300 Marks) of Part I (100 marks) and Part II (200 Marks).
7. The shortlisted candidates for the above-mentioned post/post code are hereby informed to fill the e-dossier and up-load all the documents of Educational Certificate/ Professional/Experience Certificates/Degree and Marks sheets/Caste Certificate/Proof of

Govt. Servant/Ex Servicemen/Admit Cards, etc., as applicable in the e-dossier module in OARS link in their individual accounts in OARS module.

8. Kindly note that the e-dossier link will be activated to only those candidates who have been provisionally shortlisted to upload e-dossier as per details given in para 4 above.
9. The e-dossier link shall be active from **22/04/2024 to 06/05/2024**. The candidate uploading e-dossier should ensure that he fulfills all the eligibility criteria/all essential qualifications as per RRs for the Post as on the date of Closing of application.
10. The above shortlisted candidates are also being separately informed through SMS and e-mail on their registered mobile number and e-mail ID **as an additional facility only**. If any candidate fails to upload the e-dossier during their above said period, his candidature will be rejected and no further opportunity will be given on whatsoever ground.
11. All the candidates who have shortlisted for uploading e-dossiers **MUST** upload their all requisite/applicable documents in the said link in stipulated time as mentioned above.
12. **Mere asking the candidate for up-loading documents in the e-dossier module does not confer upon him any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that if the candidate fails to upload his documents on or before the date as mentioned above he will not be given any further opportunity and his candidature will be treated as cancelled.**
13. The above shortlisting of candidates for calling of e-dossier for the post code mentioned above will be subject to outcome of pending court cases, if any.
14. While every care has been taken in preparing the list of shortlisted candidates, DSSSB reserves the right to rectify errors and omissions if any, detected at any later stage.

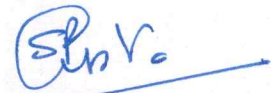
