The Competent Authority of the Department, concerned, shall issue the appointment letter to the candidates after satisfying himself of his eligibility as laid down in the recruitment rules and on verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age, Caste Certificate, Physically Handicapped Certificate and other Certificates, if any, seeking any relaxation in the eligibility standards.
