The DSSSB had closed the recruitment process for the post of TGT (English) Female, Post Code-05/13 and the unfilled vacancies were returned to the User department vide letter dated 03.04.2017. The Competent Authority of the Department, concerned, shall issue the appointment letter to the candidates after satisfying himself of his eligibility as laid down in the recruitment rules and on verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age, Caste Certificate, Physically Handicapped Certificate and other Certificates, if any, seeking any relaxation in the eligibility standards.

4. Mere inclusion of name in the result notice does not confer any right upon the candidate over the post.
