The DSSSB vide its advertisement no. 03/2017 with closing date 21/11/2017 had advertised 401 vacancies (UR-161, OBC-140, SC- 70, ST-30 including 12 EXSM) for the Post of Warder under post code 86/17 in Delhi Prison Department. The Board has conducted Physical Endurance Test (PET) for applicants of the Post Code on 01/03/2019 to 16/04/2019 (36 days) at CHHATRASAL STADIUM, MODEL TOWN, RING ROAD, DELHI-110009 and SPORTS COMPLEX, EAST VINOD NAGAR (MAYUR VIHAR PHASE-II), NEAR NEELAM MATA MANDIR, DELHI-110091.

On qualifying PET, 11001 candidates were provisionally allowed to appear for written examination for post code 86/17, subject to correctness of the information furnished by the candidates in their online application forms.

The online examination was held on 18/06/2019. The marks statement of the above Post/Post Code has been uploaded on the Board's website for information of the candidates. Candidates can view their marks by logging into their account in OARS module on www.dssbonline.nic.in.

The shortlisted candidates for the above-mentioned post/post code are hereby informed to fill the e-dossier and up-load all the documents of Educational Certificate/Certificates and Marks sheets/Caste Certificate/Proof of Govt. Servant/Ex Servicemen/Admit Cards, etc., as applicable in the e-dossier module in OARS link in their individual accounts in OARS module.

The category wise cut off marks for uploading e-dossier have been given as under:-

Category	UR	OBC	SC	ST	EXSM
Cut Off marks	108	81.25	72.50	70.50	66.75

Where the last Candidates have equal marks, in that case the candidate being older in age than other candidates in their respective category, has been shortlisted for filing up of dossier.

The link for up-loading e-dossier shall be kept open for a period of 15 days with effect from 27/09/2019 to 11/10/2019. The candidates uploading e-dossier should ensure that

he fulfills all the eligibility criteria as on the cutoff date, i.e., 21/11/2017. The shortlisted candidates are also being separately informed through SMS & E-Mail on their registered mobile number and e-mail ID. If any candidates fail to upload the e-dossier during the above said period, his/her candidature will be rejected and no further opportunity for uploading e-dossier will be given on whatsoever grounds.

Mere asking the candidate for up-loading documents in the e-dossier module does not confer his any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that if the candidate fails to upload his documents on or before the date as mentioned above he will not be given any further opportunity and his candidature will be treated as cancelled.

While every care has been taken in preparing the list of shortlisted candidates, DSSSB reserves the right to rectify errors and omissions if any, detected at any later stage.
