NOTICE NO: 827 FOOT CONSTABLE (MALE), UNDER POST CODE 44/13 IN TRANSPORT DEPARTMENT, GNCTD

- 1. The DSSSB, vide its **advertisement No. 03/2013** had advertised **200 vacancies (UR-101, OBC-54, SC-30 ST-15 including EXSM-20)** for the post of Foot Constable (Male) under post code-44/13, in Transport Department, GNCTD. The Board has conducted Physical Standard Essential (PSE) for applicants for the said post during 22.04.2019 to 05.05.2019 (14 days) at Chhatrasal Stadium, Model Town, Ring Road, Delhi-110009 and Sports Complex, East Vinod Nagar (Mayur Vihar Phase-II), Near Neelam Mata Mandir, Delhi-110091.
- 2. Out of total 83902 candidates, only 14062 candidates appeared for PSE, out of which, only 12964 candidates could qualify the PSE.
- 3. On qualifying PSE, the **12964 candidates (UR-5485, OBC-4021, SC-3020 and ST-438)** were provisionally allowed to appear for examination for Post Code-44/13, subject to correctness of the information furnished by the Candidates in their online application forms. **The examination was conducted (online mode) on 18 & 27 June, 2019**.
- 4. The marks obtained by **10734 candidates** who duly appeared in examination conducted **(online mode) on 18 & 27 June, 2019** have been uploaded on Board's website. Candidates can view their marks by logging into their account in OARS module on www.dsssbonline.nic.in.
- 5. Based on the performance in the examination, candidates, as detailed below, have been provisionally allowed to upload e-dossiers subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application forms:-

- 6. The shortlisted candidates for the above mentioned post code are hereby informed to fill the e-dossier and upload all the documents of Educational/Professional Certificate/Degree and Mark sheets/Caste certificate/Disability certificate/Proof of Govt. Servant/Ex. Serviceman/Admit Cards etc., as applicable, in the e-dossier module in OARS link in their individual account. Shortlisting is being made on the basis of marks obtained in Tier I examination (Objective-MCQ) for 200 marks.
- 7. Kindly note that the e-dossier link will be activated for only those candidates who are in the consideration zone of selection.

- 8. All the candidates who have been shortlisted for falling in the consideration zone of selection MUST upload their all requisite / applicable documents in the said link in stipulated time.
- 9. The e-dossier link shall be active from 30.09.2019 to 14.10.2019. The candidate uploading e-dossier should ensure that he/she fulfils all the eligibility criteria/all essential qualifications as per RRs for the post as on the cut-off date i.e. 18.10.2013. The above shortlisted candidates are also being separately informed through SMS and E-mail on their registered mobile number and E-mail Id. If, any candidate fails to upload e-dossier during the above said period his/her candidature will be rejected and no further opportunity will be given on whatsoever ground.
- 10 Mere asking the candidate for uploading documents in the e-dossier module does not confer him/her right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that if the candidate fails to upload his/her documents on or before the date as mentioned above he/she will not be given any further opportunity and his/her candidature will be treated as cancelled.
- 11. While every care has been taken in preparing the list of shortlisted candidates, DSSSB reserves the right to rectify errors and omissions if any, detected at any stage.
- 12. The above Shortlisting of candidates for calling of e-dossier for the post of Foot Constable (Male) under post code-44/13, in Transport Department, GNCTD is subject to outcome of pending court case viz. OA No. 1368/2019 and other court cases, if any.
