The DSSSB vide notice no. 535 dated 22/08/2017 had shortlisted 1416 candidates for the Post of Warder under Post Code 37/13 to appear for PET-III. Further, vide Notice No. 653 dated 21/05/2018 it was informed that the PET was conducted with effect from 12/02/2018 to 16/02/2018 wherein 489 candidates appeared for the Test and 132 candidates could qualify the PET. The result of the candidates having roll number 13007595, 13029611 and 13049618 were withheld vide Notice No. 653 dated 21/05/2018 for further scrutinizing their PET evaluation.

Now, the Result Status of the Candidates having roll number 13007595, 13029611 and 13049618 are being uploaded in OARS module, concerned candidates can check their status by logging into their account in OARS module on www.dsssonline.nic.in.

Based on the performance in PET-III, in addition to already allowed 132 candidates vide notice no. 653 dated 21/05/2018, only 01 candidate having roll number 13007595 who qualified the PET is provisionally allowed to up-load supplementary e-dossier subject to correctness of the information furnished by the candidate in his online application form.

Kindly note that the e-dossier link will be activated to only those candidate who has qualified the PET.

The Candidate who has been shortlisted MUST up-load his all requisite /applicable documents in the said link.

The link for up-loading e-dossier shall be kept open for a period of 10 days with effect from 30/09/2019 to 09/10/2019. The candidate uploading e-dossier should ensure that he fulfills all the eligibility criteria as on the cutoff date, i.e., 02/08/2013. The shortlisted candidate is also being separately informed through SMS & E-Mail on his registered mobile number and e-mail ID. If any candidate fails to upload the e-dossier during the above said period, his candidature will be rejected and no further opportunity for uploading e-dossier will be given on whatsoever grounds.

Mere asking the candidate for up-loading documents in the e-dossier module does not confer his any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that if the candidate fails to upload his documents on or before the date as mentioned

above he will not be given any further opportunity and his candidature will be treated as cancelled.
