**SUPPLEMENTARY RESULT NOTICE NO: 518**

**PHYSICAL EDUCATION TEACHER, POST CODE-90/17 IN DIRECTORATE OF EDUCATION.**

The DSSSB vide its advertisement No. 04/2017 dated 22/12/2017 had advertised total 919 [UR-465, OBC-244, SC-141, ST-69] vacancies for the post of **Physical Education Teacher, Post Code-90/17 in Directorate of Education** with closing date as 31.01.2018. Tier-I examination in offline written examination mode was conducted on 16/09/2018.

2. On the basis of offline examination of Tier-1 held on 16.09.2018 and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.04/2017 and RRs for the post of **Physical Education Teacher, Post Code-90/17** in Directorate of Education, a total of 725 (UR-449, OBC-113, SC-138, ST-25) candidates were provisionally nominated for the post of **Physical Education Teacher, Post Code-90/17** vide Result Notice No. 461 dated 30.05.2019 and the candidature of 34 candidates (UR-16, OBC-14, SC-03, ST-01) category was kept pending for want of deficient documents / clarification and their documents were recalled w.e.f. 06.06.2019 to 15.06.2019. This candidate was also informed separately through SMS on the registered Mobile number.

3. Out of 34 pending candidates, 11 candidates have uploaded the requisite documents / during the period 06.06.2019 to 15.06.2019 and out of them 09 candidates found eligible & 02 candidates found not eligible. Further, 08 vacancies under OBC which have been kept pending for verification of their OBC (Delhi) status are also being nominated for thorough verification regarding their OBC (Delhi) status at the level of the user department.

4. Further, some candidates have filed their representations against the rejection of their candidature, these representations have been taken into consideration and who found eligible as per RRs/DoPT instructions, their candidature has been revived and considered for post of **Physical Education Teacher Post Code-90/17**.

5. (i) Accordingly, in continuation to Result Notice No. 461 dated 30.06.2019, the candidates, as detailed below, are also provisionally selected on the basis of offline examination of Tier-1 held on 16.09.2018 and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.04/2017 and RRs for the post of **Physical Education Teacher Post Code-90/17** in Directorate of Education.

6. The candidates mentioned at 1 under OBC category has applied under Sportsperson category and uploaded sportsperson certificate. The user department is requested to ascertain as to whether this candidate fulfill the conditions under sportsperson category at their level before issuance of appointment letter. The user department is further requested to ascertain this condition in respect of those candidates who have already been nominated vide Result notice no. 461 dated 30.05.2019. If they found not eligible, their dossiers may be returned after cancellation of their candidature.

7. Further, the candidates mentioned at Sl. No. 7 is EXSM and having Graduate degree with PET course or Physical Education training course in Army and it has been mentioned in the certificates that the trade certificate/ PET certificate are equivalent with Physical Education Teacher. Therefore, this candidate is also being provisionally nominated with the request to check his eligibility conditions regarding qualification before issuance of appointment letter.

8. The selection of the above candidates shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/handwriting etc. on the application form, admission certificate etc. **The candidature of the above candidates are liable to be cancelled by the User Department also, in case the candidates are found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The decision of the User Department regarding the eligibility of the candidate shall be final and binding on the candidate.**

9. The user department shall also check the eligibility of the reservation benefit, if any. **Further, if applicable, User Department shall verify the genuineness of the Caste Certificates furnished by the candidates prior to issuing offer of appointment to the candidates.**



10. The User Department shall also get the SC/ST/OBC/PH/ExSM/etc. certificates verified from the Issuing authority. Further, if applicable, User Department shall also verify the genuineness of the caste certificates furnished by the candidates prior to issuing offer of appointment to the candidates. In case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DoPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2009 and O.M. No. 36033/1/2013-Estt. (Res) dated 27.05.2013.

11. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application form and e-dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential Certificates as per instructions issued by Govt. of India in this regard vide **MHA O.M. No. 2/29/54-RPS, 19-11-54.**

12. The user department shall ensure that the appointment made is in conformity with DoPT guidelines and instructions of Govt. issued from time to time.

13. The candidature of the following candidates is being kept pending for want of deficient documents, as per details given below. They are directed to upload their deficient/requisite/applicable documents in the e-dossier module within the stipulated time, i.e. from 30/09/2019 to 06/10/2019, failing which their candidature will be rejected and no further opportunity will be given on whatsoever ground.




Further, the candidature of the candidates bearing Roll No. 2700000265 whose candidature was rejected vide rejection notice no. 462 dated 30.05.2019 has been revived and is being kept pending for want of documents of Guest/Contract Teacher. The candidate is requested to upload the documents of experience as GCT ctgy. in the e-dossier w.e.f. 28/09/2019 to 04/10/2019.

15. The e-dossier module link for the above purpose shall be activated from 30/09/2019 to 06/10/2019.

16. Further, the candidature of 03 candidates bearing Roll No. 2700014396, 2700000360, 2700005126 who were nominated earlier under UR category vide Result Notice No. 461 dated 30.05.2019 have been withdrawn for having lower marks in merit. Even though these candidates having equal marks to last selected candidates under UR category, but their candidature has been withdrawn and kept in waiting as per condition at sub para-vii of para-2 (Mode of Selection) in Advt. No. 04/17 that "If there are two or more candidates in the same category having equal marks in the examination, the candidate older in age will get preference".

17. The result process for the above post code stands closed in all respect except 10 vacancies (UR-07, OBC-02, SC-01) which have been kept pending for want of clarification / essential document in the e-dossier/court case as referred above.

18. A waiting panel has been prepared which will be valid for a period of one year from the date of declaration of result i.e. upto **29.05.2020** as per earlier result notice no. 461 dated 30.05.2019.


19. Mere inclusion of name in the result notice does not confer any right upon the candidate over the post.
