RESULT NOTICE NO. 521

TGT (HINDI), FEMALE POST CODE-07/13 IN DIRECTORATE OF EDUCATION

- 1. Whereas Ms. Neelam Yadav has filed an O.A No. 2688/2017, titled Neelam Yadav Vs. DSSSB & Ors , and the Hon'ble CAT has_disposed off the said O.A. vide order dated 04.10.2018 wherein the operative part is as under:
 - i) The Deputy Commissioner (North West District), GNCTD is directed to verify the Caste status of the applicant within a period of two months from the date of this order. Obviously, while doing so, the period of her residing in Delhi is to be verified and so also it is to be reconfirmed as to whether her caste is included in the list of OBC of GNCTD or not.
 - ii) If the Deputy Commissioner (North West District), GNCTD issues an OBC Caste certificate to the applicant afresh, the same shall be considered by the DSSSB in terms of her having been declared successful in the written examination for the post of TGT (Hindi) Post Code-07/13, the DSSSB shall recommend her for appointment to the said post to the Director of Education, respondent No.3, within four weeks of the receipt of the Caste certificate.
- 2. Whereas, Ms. Neelam Yadav had applied for the post of TGT (Hindi) Female under Post Code-07/13. Since the candidate was falling under consideration zone, she was called in the Board along with originals and photocopies of all the certificates related to her educational qualification, Caste certificate etc for verification of documents on 21.04.2017.
- 3. Whereas, On Scrutiny of the documents submitted by Ms. Neelam Yadav at the time of verification of documents, it was found that Ms. Neelam Yadav acquired all her educational qualification from Uttar Pradesh and the OBC certificate was issued by Executive Magistrate, Model Town on the basis of OBC certificate issued to her brother who is also a resident of Uttar Pradesh. Accordingly, Ms. Neelam Yadav was treated as OBC (Outsider) and her candidature for the post of TGT (Hindi) Female, Post Code-0713 under OBC (Delhi) category was rejected vide Rejection Notice No.159 dated 30.06.2017.

- Whereas, Ms. Neelam Yadav submitted a representation dated 01.11.2018 thereby enclosing a fresh OBC certificate No.90500000467468 dated 29.10.2018 stating that same has been issued by Revenue department in response to the CAT's order dated 04.10.2018.
 - **5.** Whereas, a letter dated 19.12.2018 was written to Deputy Commissioner (North-West) with the request to direct the concerned Revenue Authority to get the matter examined thoroughly in the light of directions issued by Hon'ble CAT and intimate to DSSSB about the OBC(Delhi) status of Ms. Neelam Yadav.
 - **6.** Whereas, Tehsildar, Saraswati Vihar issued a Notice dated 06.04.2019 vide which Ms. Neelam Yadav was directed to appear in person before him along with supporting documents.
 - 7. Whereas, Tehsildar, Saraswati Vihar forwarded an OBC certificate verification report No.1637 dated 06/06/2019 to DSSSB concluding that after going through the facts and scrutiny of the documents submitted by Ms. Neelam Yadav, it is found that the certificate No.90500000467468 dated 29.10.2018 is found genuine and issued on the basis of documents provided by the applicant.
 - 8. Whereas, Ms. Neelam Yadav approached the Hon'ble CAT vide OA No.2688/2017 and the Hon'ble CAT vide order dated 04.10.2018 as reproduced in para 1 of this notice, had ordered to consider the applicant's case for nomination for the said post if Revenue Department issues a fresh OBC Caste certificate to her. The candidate has now approached the Hon'ble CAT seeking contempt proceedings against the Board vide CP No. 100/78/2019, for having failed to implement the orders dated 04.10.2018, as detailed in para 1 of the notice herein above.
 - 9. Now Therefore, In compliance of the Hon'ble CAT order dated <u>04.10.2018</u> in <u>OA No. 2688/2017</u>, titled <u>Neelam Yadav Vs. GNCTD & Others</u>, since the candidate had qualified the examination and was placed higher in merit than the last selected candidate in OBC category. Accordingly, the <u>Rejection Notice No.159 dated 30/06/2017</u> in r/o Ms. Neelam Yadav (Roll No. 45001155) stands cancelled and Ms. Neelam Yadav (Roll No. 45001155) is provisionally nominated under OBC Category for the post of TGT (Hindi) Female, Post Code-07/13 in Directorate of Education.
 - 10. The selection of the above candidate shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidate is liable to be cancelled by the User

- Department also, in case the candidates is found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The decision of the User Department regarding the eligibility of the candidate shall be final and binding on the candidate.
- 11. The User department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, User Department shall verify the genuineness of the Caste Certificate furnished by the candidate prior to issuing offer of appointment to the candidates.
- the appointment letter to the candidates after being satisfied about their eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application for and e dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential certificates as per Instructions issued by Govt. of India in this regard vide MHA OM No.2/29/54-RRs 19-11-54.
- 13. The User department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt issued from time to time.
- 14. Further, the nomination of Ms. Babita (Roll No. 45000114) which was earlier mentioned in Result Notice No 158 dated 30.06.2017 at S.N.06 in OBC Category, is hereby withdrawn. User Department is requested to convey the decision to the candidate and return her dossier to DSSSB.
- 15. Mere inclusion of name in the result notice does not confer any right upon the candidate over the post unless the user department is satisfied after such inquiry as may be considered necessary that the candidate is suitable for the said post.
- 16. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any.

17. This issues with the approval of Competent Authority, DSSSB.
