TGT (English), POST CODE-132/17 IN DIRECTORATE OF EDUCATION

The DSSSB vide its advertisement No.04/2017 DATED 20/12/2017 had advertised total **311 vacancies (UR-125, OBC-67, SC-57 & ST-62(including PH/OH-04 & PH/VH-05)** for the post of **TGT (English) Female under Post code-132/17** in Directorate of Education with closing date as **31.01.2018**. Tier-I examination in online computer based examination mode was conducted on **08.09.2018**.

- 2. On the basis of online examination of Tier-1 held on 08.09.2018 and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.04/2017 and RRs for the post of TGT(English), Post Code-132/17 in Directorate of Education, a total of 251 (UR-116, OBC-54, SC-55, ST-22, PH/OH-02 & PH/VH-02) were provisionally nominated vide Result No.451 dated 28/05/2019 and the candidature of 18 candidates (02- UR, 11-OBC, 02-SC UR-PH/OH-02 and OBC-PH/VH-01) were kept pending for want of clarification/documents and their documents were recalled w.e.f. 29.05.2019 to 07.06.2019. These candidates were also informed separately through SMS on their registered Mobile Number and out of these the candidature of 07-OBC category candidate was kept pending for verification of their OBC (Delhi) status from Revenue department.
- 3. Out of these 11 candidates, whose candidature were kept pending for deficient documents, 09 candidates have uploaded the requisite documents and after scrutiny of the documents uploaded by these candidates, 08 candidates were found eligible and is being provisionally nominated and 01 candidate was found ineligible and her candidature is being rejected. Further, the candidature of 07 candidates under OBC category which has been kept pending for verification of their OBC (Delhi) status is also been nominated for thorough verification regarding their OBC (Delhi) status at the level of the user department.
- **4.** Accordingly, in continuation to Result Notice No.**451** dated **28.05.2019**, the candidates detailed below are also provisionally selected on the basis of online examination of Tier-I held on 08.09.2018 and having been found provisionally eligible as per documents uploaded in support of educational qualification etc. in accordance with advertisement No.04/2017 and RRs for the post of **TGT(English) Post Code-132/17**.

5. The selection of the above candidate shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidates are liable to be cancelled by the User Department also, in case the candidates are found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as laid down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.



- 6. The User department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, User Department shall verify the genuineness of the Caste Certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the application forms and e-dossier vis-à-vis the original documents. The User department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User department is also requested to rectify/correct, in case any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
- 7. The User department shall verify the genuineness of the Caste certificate furnished by the candidates in the light of Notification No.36012/22/93-Estt.(SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the Competent authorities prior to issuance of offer of appointment to the candidate. It is further stated that prior to appointment, the user department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC(Delhi) certificate as specified in various orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Deptt., GNCTD after thorough verification of Caste Certificate.
- 8. The User Department shall also get the SC/ST/OBC certificates verified from the Issuing authority. Further, if applicable, User department shall verify the genuineness of the Caste certificate furnished by the candidate prior to issuing officer of appointment to the candidates. in case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DOPT O.M. No.36012/22/93-Estt.(SCT) dated 08.09.1993, O.M. No.36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2009 and 36033/1/2013-Estt. (Res) dated 27.05.2013.
- **9.** The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application for and e dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential certificates as per Instructions issued by Govt. of India in this regard vide **MHA OM No.2/29/54-RRs 19-11-54**.
- 10. Further, the candidature of candidates at S.No.4(v) of OBC category were kept pending earlier for want of verification of their OBC status. Since the verification of OBC status from Revenue Department is taking considerable period of time and delaying the recruitment process, the Board has decided to provisionally nominate these candidates and the User department may verify the OBC status of the candidates from the Revenue department as per the guidelines issued by GNCT of Delhi vis a vis documents filed by the candidates with regard to his/her place

- 11. The User department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt issued from time to time.
- 12. Further, the candidature of 02 candidates is kept pending for insufficient documents, as per details given below. They are being given second and final opportunity to upload pending/ requisite/applicable documents in the e dossier module within the stipulated time, i.e. from 14/10/2019 to 20/10/2019 failing which their candidature will be rejected and no further opportunity will be given whatsoever:-

- 14. Further, candidature of Ms. Preeti Sharma (Roll No. 2660020924) which has been rejected vide Rejection Notice No.449 dated 28.05.2019, is also being revived.
- **15.** Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the User department is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
- **16.** The recruitment process for the post of TGT(English), Post Code-132/17 stands closed in all respect.
- **18.** Further, as per result notice no. 451 dated 28/05/2019 wait list panel for the post code 132/17 shall be valid for a period of one year, i.e. upto 27.05.2020.
