## REJECTION NOTICE NO. 830 GRADE IV (DASS)(POST CODE 61/2015) IN SERVICES DEPARTMENT,

In view of FIR No. 0010/2018 lodged against the candidate due to impersonation, having roll no. 15423213, in respect of the above mentioned post code, the candidate has been found 'Not Eligible' in terms of the advertisement no. 01/2015 and the Recruitment Rules for the post of Grade IV (DASS), under Post Code 61/15 in Services Department. The candidature of this candidate, therefore, stands rejected on following grounds:

2. The Candidates appearing in various examinations being conducted by the DSSSB have repeatedly been warned not to resort to any unfair means/malpractices and further, that:

'Any attempt to commit or abet, as the case may be, all or any of the acts such as (i) Impersonating, and (ii) Procuring impersonation by any person, may in addition to rendering himself/herself liable to criminal prosecution, be liable:

- a) To be disqualified by the Board from the examination for which he/she is a candidate as also from any other examination/selection of the Board in which he/she might have appeared but the final result/selection has not been declared/made and or
- b) To debarred either permanently or for a specified period which may extend to 10 years by the Board from any examination held or selection made by them and or,
- c) To take disciplinary action under appropriate rules if he/she is already in service under Government and or,
- d) To take any other legal action.'
- 3. During Skill Test held on 05/01/2018 at Bhai Parmanand Institute of Business Studies, Shakarpur, Delhi-110092, it was found that Sh. Manish Chikara, S/o Satbir Singh, R/o VPO Karepur, Police Station Bahadur Gardh, Distt. Jhajjhar, Haryana appeared in place of the candidate namely, Sh. Nitesh Bhardwaj (Roll No. 15423213), S/o Jitender Kumar, R/o H. No. 410, Near Dada Maiwala Mandir, Village Banker, Narela, Delhi 110040 by using PAN No. CEFPB4589A. The Photograph on the PAN Card and signature of the impersonator, Sh. Manish Chikara was not matching with the candidate Sh. Nitesh Bhardwaj and therefore, a FIR No. 0010/2018 was lodged u/s 419/120B against the candidate and his impersonator.
- 4. Thus, it is clear that the candidate Nitesh Bhardwaj (DOB:- 22/01/1992) having roll no. 15423213 had arranged to have another person taking Skill Test for himself, for this post code 61/15, on 05/01/2018 from 3:30 PM to 5:00 PM at Bhai Parmanand Institute of Business Studies, Shakarpur, Delhi-110092. Thus the candidate Nitesh Bhardwaj and the impersonator have indulged in the following activities amounting to impersonation:-

- a) Appearing in examination for another candidate or arranging to have another person take an examination for the candidate.
- b) Allowing/Making somebody else to write answers on candidate's behalf during examination.
- c) Helping or receiving help from other candidates to impersonate.
- d) Signing / getting signed the attendance sheet and other examination documents on somebody else's behalf either partially or completely.
- e) Proving admit card and PAN Card to another person to enable him to appear on behalf of the candidate
- 5. Further, this candidate along with the impersonator have also indulged in the act of forgery by altering the identity proof of candidates, admit card etc and produced this documents to the examination conducting functionaries with the intent to defraud, as the documents produced are materially different from the records available with the DSSSB.
- 6. Therefore, it is evident that the candidate Nitesh Bhardwaj along with impersonator was actively involved in the crime related to impersonation, cheating, forgery, connivance and conspiracy as specified in Indian Penal Code.
- 7. In view of the above facts and circumstances, the DSSSB has come to the conclusion that, prima facie, a case of impersonation, cheating, forgery, connivance and conspiracy is made out against the Candidate mentioned:-

- 8. Furthermore, attention is drawn to the following provisions at Para No. 15, 17, 18 and 20 of the "General Instructions for Candidates for the Post Code 61/15 in Skill Test dated 05/01/2018.
- "15. The candidature of skill test is provisional. The candidates should satisfy themselves regarding possession of the required Qualification, age, and caste etc., stipulated in the announcement for the post. He/She will be treated as debarred ab initio in case he/she does not fulfill eligibility criteria. The Board reserves the right to reject the candidature of any ineligible candidate at any stage of recruitment.
- 17. If any candidate is found using any unfair means, he/she will be debarred from the skill test and/or necessary legal action be initiated.
- 18. The candidature of the candidate to the Typing Test is entirely provisional and subject to the outcome of any direction/decision/order/pronouncement of any court of law and mere issue of admit card or appearance at the examination/Test does not entitled him/her to any claim for the post.



- 20. The Board reserves the right to cancel a part of or entire process of examination due to administrative reasons and in case of unfair means, cheating or other irregularities/malpractice notice by the Board. The Board also reserves the right to cancel or set up a new examination schedule/center and divert the candidates to appear at that examination center, if required."
- 9. The DSSSB also adheres to Zero tolerance Policy towards any misconduct by any candidate or any person. Therefore, in view of the above facts and circumstances, the candidature of the candidate Nitesh Bhardwaj (DOB: 22/01/1992) having roll no. 15423213 for the post of Grade IV in Services Department, under Post Code 61/15 is hereby cancelled, on finding him involved in the acts as mentioned above.

This issues with the prior approval of the Competent Authority.
