TGT (NATURAL SCIENCE) FEMALE POST CODE-11/13 IN DIRECTORATE OF EDUCATION

The DSSSB vide its advertisement No. 01/2013 had advertised total 186 [UR-80, OBC-20, SC-55, ST-31, including PH (OH-03)] vacancies for the post of **TGT (Natural Science) Female, Post Code-11/13 in Directorate of Education** with closing date as 20.03.2013. Tier-I examination in offline examination mode was conducted on 28/12/2014.

2. On the basis of offline examination of Tier-1 held on 28.12.2014 and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.01/2013 and RRs for the post of **TGT (Natural Science) Female, Post Code-11/13** in Directorate of Education, a total of 119 (UR-79, OBC-16, SC-21, ST-03 including UR/OH-01) candidates were provisionally nominated for the post of **TGT (Natural Science) Female, Post Code-11/13** vide Result Notice No. 57 dated 03.08.2016, Result Notice No. 91 dated 07.10.2016, Result Notice No. 112 dated 24.01.2017, Result Notice No. 131 dated 24.03.2017, Result Notice No. 168 dated 16.08.2017, Result Notice No. 502 dated 04.09.2019 and the candidature of 03 candidates (UR-01, OBC-02) was kept pending for want of deficient documents / clarification. Further, 02 candidates under OBC category were kept pending for verification of their OBC (Delhi) status.

3. 03 candidates who have kept pending for want of documents/clarifications have provided the requisite documents 03 candidates are found eligible. Further, 02 OBC category vacancies which have been kept pending for verification of their OBC (Delhi) status are also being nominated for thorough verification regarding their OBC (Delhi) status at the level of the user department.

4. (i) Accordingly, in continuation to Result Notice No. 57 dated 03.08.2016, Result Notice No. 91 dated 07.10.2016, Result Notice No. 112 dated 24.01.2017, Result Notice No. 131 dated 24.03.2017, Result Notice No. 168 dated 16.08.2017, Result Notice No. 502 dated 04.09.2019, the candidates, as detailed below, are also provisionally selected on the basis of offline examination of Tier-1 held on 28.12.2014 and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.01/2013 and RRs for the post of **TGT (Natural Science) Female, Post Code-11/13** in Directorate of Education.

The selection of the above candidates shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/handwriting etc. on the application form, admission certificate etc. **The candidature of the above candidates are liable to be cancelled by the User Department also, in case the candidates are found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The decision of the User Department regarding the eligibility of the candidate shall be final and binding on the candidate.**

6. The user department shall also check the eligibility of the reservation benefit, if any. **Further, if applicable, User Department shall verify the genuineness of the Caste Certificates furnished by the candidates prior to issuing offer of appointment to the candidates.**

7. The User Department shall also get the SC/ST/OBC/PH/ExSM/etc. certificates verified from the Issuing authority. Further, if applicable, User Department shall also verify the genuineness of the caste certificates furnished by the candidates prior to issuing offer of appointment to the candidates. In case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DoPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2009 and O.M. No. 36033/1/2013-Estt. (Res) dated 27.05.2013.

8. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application form and e-dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential Certificates as per instructions issued by Govt. of India in this regard vide **MHA O.M. No. 2/29/54-RPS, 19-11-54.**

9. **The user department shall ensure that the appointment made is in conformity with DoPT guidelines and instructions of Govt. issued from time to time.**

10. The result process for the above post code stands closed in all respect and waiting panel has already been expired on 02.08.2017 as per earlier result notice no. 57 dated 03.08.2016.

11. **Mere inclusion of name in the result notice does not confer any right upon the candidate over the post.**
