PHYSICAL EDUCATION TEACHER, FEMALE, POST CODE-95/17 IN DIRECTORATE OF EDUCATION

The DSSSB vide its advertisement No.04/2017 DATED 20/12/2017 had advertised total 74 vacancies (UR-37, OBC-20, SC-11 & ST-06 for the post of **Physical Education Teacher under Post code-95/17** in Directorate of Education with closing date as 31.01.2018.

- 2. On the basis of marks secured in the written examination and after preliminary scrutiny as per the provisions of the statutory Recruitment Rules for the post and the terms and conditions of the advertisement, a total of 60 (UR-32, OBC-16, SC-11, ST-01) were provisionally nominated vide Result No. 410 dated 23/04/2019.
- 3. Further, the candidature of **09 candidates** were kept pending for want of clarification/documents and their documents were recalled w.e.f. **13.09.2019 to 22.09.2019 vide notice dated11.09.2019**. These candidates were also informed separately through SMS on their registered Mobile Number.
- **4.** Out of these **09** candidates, **07** candidates have uploaded the requisite documents and on scrutiny of the documents uploaded by these candidates, **06** candidates are found eligible and **01** candidate is found ineligible for not fulfilling the eligible conditions as per RR.
- **5.** Accordingly, in continuation to Result Notice No.**410** dated **23.04.2019**, the candidates mentioned at para No. 4 are also provisionally selected on the basis of written examination and having been found provisionally eligible as per documents uploaded in support of educational qualification etc. in accordance with advertisement No.04/2017 and RRs for the post of **Physical Education Teacher**, **Post code-95/17**, as detailed below:-

Note:_- The candidates mentioned at S.N. 02 in UR category having Roll No. 2340001779, at S.N. 02 in OBC category having Roll No. 2340001724 and at S.N. 01 in ST category having Roll No. 2340001724 had acquired their B.P.ED/M.P.ED degree from Chaudhary Devilal University, Sirsa, Haryana / Lakshmi Bai Institute Gwalior, M.P. As per record available on NCTE website the recognition of Chaudhary Devilal University, Sirsa, Haryana to run M.P.ED./B/P.ED. courses has been withdrawn vide order dated 10/06/2019 and it is not clear whether at present the said institutes i.e. Chaudhary Devilal University & Sirsa, Haryana / Lakshmi Bai Institute Gwalior, M.P. are recognized by NCTE to run M.P.ED./B/P.ED. courses Further, the candidate mentioned at S.N. 01 in OBC category having roll No. 2340000779 has worked as Guest Teacher in SCERT. The user department is requested to confirm about recognition of the said institutes by NCTE for running B.P.ED/M.P.ED courses and validity of Guest Teacher experience in the light of RRs for post code 95/17 before issuing offer of appointment to the above said candidates. If the candidates are not found suitable as per RRs, their candidature may be canceled and their dossier may be returned to DSSB.

6. The candidature of the following **03 (Three**) candidates have been kept pending due to the reasons mentioned against their Roll No.:-

7. The above pending total 02 candidates in UR category are given 2nd and final opportunity to upload their pending documents/all

requisite/ applicable documents etc if any, through the e-dossier module in stipulated time failing which their candidature will be rejected and no further opportunity for uploading e-dossier will be given on whatsoever ground. Further, 01 candidate in OBC category having Roll No. 2340001559 is also directed to upload her pending documents/all requisite/ applicable documents etc if any, through the e-dossier module in stipulated time failing which her candidature will be rejected without any further notice.

- 9. The e-dossier link shall be active from **05.11.2019** to **09.11.2019**. The above candidates are also being separately informed through, SMS and on their registered mobile number. If, any candidate fails to upload required documents through e-dossier during the above said period his/her candidature will be rejected without any further notice.
- 10. The selection of the above 06 (Six) candidate [UR-03,OBC-02 and ST-01] shall be further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidates are liable to be cancelled by the User Department also, in case the candidates are found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The decision of the User Department regarding the eligibility of the candidate shall be final and binding on the candidate.
- **11.** The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as laid down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates including caste certificate as per Government of India instructions issued in this regard vide MHA OM No. 2/29/54-RPS dated 19/11/54.
- 12. The User department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, User Department shall verify the genuineness of the Caste Certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the application forms and e-dossier vis-à-vis the original documents. The User department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User department is also requested to rectify/correct, in case any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.

- 13. The User department shall verify the genuineness of the Caste certificate furnished by the candidates in the light of Notification No.36012/22/93-Estt.(SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the Competent authorities prior to issuance of offer of appointment to the candidate. It is further stated that prior to appointment, the user department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC(Delhi) certificate as specified in various orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Deptt., GNCTD after thorough verification of Caste Certificate.
- 14. The User Department shall also get the SC/ST/OBC certificates verified from the Issuing authority. Further, if applicable, User department shall verify the genuineness of the Caste certificate furnished by the candidate prior to issuing officer of appointment to the candidates. in case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DOPT O.M. No.36012/22/93-Estt.(SCT) dated 08.09.1993, O.M. No.36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2009 and 36033/1/2013-Estt. (Res) dated 27.05.2013.
- 15. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application for and e dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential certificates as per Instructions issued by Govt. of India in this regard vide MHA OM No.2/29/54-RRs 19-11-54.
- 16. The User department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt issued from time to time.
- **17.** Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the User department is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
- 18. The recruitment process for the post code-95/17 had already been closed subject to disposal of above pending cases and subject to outcome of pending court cases, if any.
- **19.** The marks of last provisionally nominated candidate in each category after this result are as follows:-
