ASSISTANT GRADE-III, POST CODE-57/13 IN DELHI TRANSCO LIMITED.

The DSSSB vide its advertisement No. 03/2013 dated 12/09/2013 had advertised total **38** [UR-02, OBC-27, ST-09 including 01 PH(OH)] vacancies for the post of **Assistant Grade-III, Post Code-57/13 in Delhi Transco Limited** with closing date as 18.10.2013. Tier-I offline written examination was conducted on **24/09/2017**. Further, as per Recruitment Rules and clarification provided by the user department, a computer based skill test of the qualified shortlisted candidates was held on 04.01.2019, 05.01.2019 & 06.01.2019.

- 2. All 1939 candidates who had appeared in written examination were informed through notice No. F. No. 110/Rect./Asstt. Grade-III/Int. Cell/Result/DSSSB/2018-19/605 dated 21/06/2018 on the Board's website i.e. www.dsssb.delhi.gov.in that their marks for the examination dated 24/09/2017 for the post of Assistant Grade-III, Post Code-57/13 had been declared and the same were available in their account in OARS module. Further, vide notice dated 11.09.2019, the candidates who were appeared in the skill test were informed result of skill test and 37 shortlisted candidates who qualified the skill test were given the opportunity to upload their documents in the e-dossier module w.e.f. 13.09.2019 to 27.09.2019 with the specific direction that if any candidate fails to upload the e-dossier during the above said period, his/her candidature will be rejected and no further opportunity for uploading e-dossier will be given on whatsoever ground. In all a total of 31 candidates have uploaded their documents in the e-dossier portal and 06 candidates failed to upload their documents in the e-dossier.
- 3. On the basis of marks secured in the written examination and after preliminary scrutiny as per the provisions of the statutory Recruitment Rules for the post and the terms and condition of the advertisement, the following 29 Candidates (UR-01, UR/PH (OH)-01, OBC-23, ST-04) are provisionally calcated for the post of Assistant Grade-III, Post Code-57/13 in Delhi Transco Limited subject to their fulfilling all other conditions of eligibility and also correctness of the information furnished by the candidates in their online application form and e-dossier:-

- **4.** It is highlighted that besides Graduation as essential qualification, the candidate must have knowledge of computer operation including complete knowledge of MS office. In order to judge the second part regarding computer knowledge, related questions have already been included in the T-I examination. However, the user department may check this aspect at their level.
- 5. The selection of the above candidates shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidates are liable to be cancelled by the User Department also, in case the candidates are found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The decision of the User Department regarding the eligibility of the candidate shall be final and binding on the candidate.
- 6. The user department shall also check the eligibility of the reservation benefit, if any. <u>Further, if applicable, User Department shall verify the genuineness of the Caste Certificates furnished by the candidates prior to issuing offer of appointment to the candidates.</u>
- 7. The User Department shall also get the SC/ST/OBC/PH/ExSM/etc. certificates verified from the Issuing authority. Further, if applicable, User Department shall also verify the genuineness of the caste certificates furnished by the candidates prior to issuing offer of appointment to the candidates. In case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DoPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2009 and O.M. No. 36033/1/2013-Estt. (Res) dated 27.05.2013.
- 8. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application form and edossier vis-à-vis the original documents related to Educational Qualification, Age and other essential Certificates as per instructions issued by Govt. of India in this regard vide MHA O.M. No. 2/29/54-RPS, 19-11-54.
- 9. The user department shall ensure that the appointment made is in conformity with DoPT guidelines and instructions of Govt. issued from time to time.
- 10. A waiting panel of qualified candidates is available subject to their eligibility and call of e-dossier.
- 11. The category wise marks of last selected candidates are given as follows:-
