RESULT NOTICE NO:867 FOOT CONSTABLE (MALE) UNDER POST CODE 44/13 IN TRANSPORT DEPARTMENT, GNCTD

- 1. The DSSSB, vide its advertisement No. 03/2013 had advertised 200 vacancies (UR-101, OBC-54, SC-30 ST-15 including EXSM-20) for the post of Foot Constable (Male) under post code-44/13, in Transport Department, GNCTD. The Board has conducted Physical Standard Essential (PSE) for applicants for the post of Foot Constable (Male) under post code-44/13 in Transport Department during 22.04.2019 to 05.05.2019 (14 days) at CHHATRASAL STADIUM, MODEL TOWN, RING ROAD, DELHI-110009 and SPORTS COMPLEX, EAST VINOD NAGAR (MAYUR VIHAR PHASE-II), NEAR NEELAM MATA MANDIR, DELHI-110091.
- 2. Out of the total 83902 candidates, only 14062 candidates appeared for PSE, out of which, only 12964 candidates could qualify the PSE.
- 3. On qualifying PSE, the 12964 candidates (UR-5485, OBC-4021, SC-3020 and ST-438) were provisionally allowed to appear for written examination for Post Code-44/13, subject to correctness of the information furnished by the Candidates in their online application forms.
- **4.** The written examination (online mode) was conducted on 18^{th} & 27^{th} June, 2019.
- 5. The marks of all 10736 candidates who duly appeared in written examination have been declared vide notice no. 827 dated 26.09.2019. The e-dossier link was activated w.e.f. 30.09.2019 to 14.10.2019.
- 6. The result has been processed keeping in view of the eligibility conditions and relaxation thereof in respect of educational qualifications etc. as on cut off date i.e. 18.10.2013 for post code-44/13
- 7. On the basis of marks secured in the written examination and after preliminary scrutiny, as per the provisions of the statutory Recruitment Rules for the post and the terms and conditions as stipulated in the advertisement, the following 177 (UR-90 including 01-EXSM, OBC-47 INCLUDING 01-EXSM,SC-26,ST-14)candidates are provisionally selected to the post of post of Foot Constable (Male) under post code-44/13, in Transport Department, GNCTD subject to their fulfilling all other conditions of eligibility and also correctness of the information all other conditions of eligibility and also correctness of the information furnished by the candidates in their online application form and e-dossier:-

The provisional selection of the above **Total 177 candidates [UR-90 including 01-EXSM, OBC-47 INCLUDING 01-EXSM, SC-26, ST-14]** shall be further subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/ handwriting etc. On the application form, admission certificate etc. The candidature of the candidate is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules for the posts or for any other genuine reason. The decision of the User Department regarding the eligibility of the candidate shall be final and binding on the candidate.

- 18. The above FIVE (05) candidates (UR-02, OBC-02, SC-01), whose documents are deficient, are directed to upload their deficient documents / all requisite / applicable documents etc., if any, through the e-dossier module in stipulated time. The e-dossier link shall be active from 28/11/2019 to 07/12/2019. They are also being separately informed through, SMS on their registered mobile number.
- 19. The User department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application forms and e-dossier vis-à-vis the original documents. The user Department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also

No. 36012/22/93-Estt.(SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14/10/2008 and 36033/1/2013-Estt. (Res) dated 27.05.2013.
- **22.** The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after verification of the correctness of the information furnished in the application form and the documents related to education qualification, age and other essential certificates including caste certificate as per Government of India instructions issued in this regard <u>vide MHA OM No. 2/29/54-RPS, 19/11/54</u>.
- 23. The User department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt issued from time to time.
- 24. Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the user department is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
- 25. The recruitment process for the post code-44/13 has been closed subject to disposal of pending vacancies and outcome of all the relevant pending court cases i.e. O.A. No. 100/1368/2019 and 1798/2019 with MA no. 2003/2019 is running/pending under post code 44/13 and if any.
- **26.** The waiting panel for the post of Foot Constable (Male), under Post Code-44/13 in Transport Department, GNCTD has been maintained in respect of UR/OBC/SC/ST category and the same shall be valid upto **24.11.2020**.
