REJECTION NOTICE 552

The DSSSB vide its advertisement No.04/2017 DATED 20/12/2017 had advertised total 126 vacancies (UR-59, OBC-38, SC-18 & ST-11 including PH/OH-02 & PH/VH-02) for the post of **TGT (Punjabi) under Post code-143/17** in Directorate of Education with closing date as 31.01.2018. Tier-I examination in online computer based examination mode was conducted on **27.09.2018**.

2. On the basis of online examination of Tier-1 held on 27.09.2018 and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.04/2017 and RRs for the post of TGT(Punjabi), Post Code-143/17 in Directorate of Education, a total of **44 (UR-26, UR-PH/OH-02, OBC-01, SC-15)** were provisionally nominated for the post of TGT(Punjabi) vide Result Notice **No.423** dated **30.04.2019** and the candidature of **02 candidates** under **SC category** was kept pending for want of documents and their documents were recalled w.e.f. **02.05.2019 to 11.05.2019**. These candidates were also informed separately through SMS on their registered Mobile Number. These **02** candidates, whose candidature were kept pending for deficient documents, uploaded some documents. However, on scrutiny of the documents uploaded by these candidates, it was noticed that the documents uploaded by them are different from requisite documents. Accordingly, vide Notice dated 09/10/2019 **second and final opportunity was given to them to upload pending/ requisite/applicable documents in the e dossier module from 14/10/2019 to 20/10/2019 clearly mentioning that failing which their candidature will be rejected and no further opportunity will be given on whatsoever grounds.**

3. However, on the scrutiny of the documents uploaded by them during the above said period, it was observed that these 02 candidates failed to upload requisite documents within the stipulated time.

4. Now therefore, the candidature of following 02 pending candidates is being rejected for the reason mentioned against their Roll No.s :-

| 1 | 120114300051 | Did not upload first page of e-admit card which was a mandatory document as per e-dossier module |
| 2 | 110714300027 | Did not upload CTET certificate to the effect that CTET has been qualified by her. As per CTET marks sheet uploaded by her she has scored 72 marks which is below the qualifying marks applicable for SC category |
