ORDER

1. Whereas, Ms. Deepika (Roll No. 2490000006, category-UR/PH (OH) had applied for the post of Educational and Vocational Guidance Counseling (Female) under post code-149/17 advertised by Advertisement No. 04/17. Since the candidate was falling under consideration zone, she was directed to upload her documents related to Educational qualification/experience/age etc in the e-dossier module w.e.f. 09.01.2019 to 18.01.2019 vide notice dated 04/01/2019. She was also informed through SMS & Email.
2. Whereas, on scrutiny of the documents uploaded by Ms. Deepika, it was found that she had uploaded B.A. degree & marks sheet in place of Diploma in Guidance and Counseling & its marks sheets. Accordingly, her candidature was rejected vide **Rejection Notice No. 490 dated 02.08.2019**.
3. Whereas, Ms. Deepika submitted a representation dated 12/09/2019 stating that she has qualified diploma in guidance and counseling in the year of 2016 but due to some confusion she did not upload the same. She has also enclosed the copy of diploma dated 11/01/2019 wherein it has been mentioned that she has completed the course of study-PG Diploma in Guidance and Counseling during January, 2016 to December, 2016.
4. Whereas, Ms. Deepika, also approached the Hon'ble CAT vide O.A. No. 1751/2019 & 2524/2019 for redressal of her above said grievance.
5. Whereas, the representation dated 12/09/19 submitted by Ms. Deepika (Roll No. 2490000006) was considered and it was decided to provide her a chance to upload the document as requested by her in said representation, as the request stands covered under Board's policy.
6. Now, therefore, the candidature of Ms. Deepika (Roll No. 2490000006) category- UR/PH/OH which was rejected vide Rejection Notice No. 490 dated 02.08.2019 is now being revived and she is directed to upload the Diploma in Guidance & Counseling and its marks sheets before cutoff date in the e-dossier module within the stipulated time, i.e. from **04/12/2019 to 13/12/2019** as Board accepts all the documents from candidate only through e-dossier module.
7. The e-dossier link for above purpose shall remain activated w.e.f. **04/12/2019 to 13/12/2019**.
8. This issues with the prior approval of the Competent Authority, DSSSB.
