1. The DSSSB vide its advertisement no. **02/2012** with closing date **15/06/2012** had advertised **04 vacancies (UR-02, OBC-01 & SC-01)** for the Post of Assistant Labour Welfare Officer under post code 43/12 in MCD. Board Conducted Tier-I (T) written examination for recruitment in respect of this post on **20/10/2019**.

2. The marks obtained by **19** candidates who have duly appeared in the written examination (offline mode) held on **20/10/2019** have been uploaded on Board's website. Candidates can view their marks by logging into their account in the OARS Module on www.dsssbonline.nic.in.

3. Based on the performance in Tier-I written examination, out of these 19 candidates, 02 candidates as detailed below, have been provisionally shortlisted to appear in Tier-II examination subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application forms. The shortlisted candidates shall be called for Tier-II examination separately.

4. Only those candidates have been considered in OBC category who has declared that they had obtained their caste certificate from Delhi State in their online examination form.

5. Since documents have not been called from the candidates along-with the application forms as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of name in the list of candidates qualifying for appearing in Tier-II examination does not entitled them any right over the post.

6. As per the Board Notice dated 26/04/2013 the minimum qualifying marks in One Tier written examination for UR category candidate is 40%, for OBC candidate is 35% and for SC/ST/PH is 30%.

7. 02 (OBC-02) candidates who are qualified in Tier-I examination have been shortlisted for appearing in Tier-II examination.

8. The details of Tier II Examination shall be notified separately by the Board. The candidates are advised to check the website of the Board regularly.

9. While every care has been taken in preparing the list of shortlisted candidates, DSSSB reserves the right to rectify errors and omissions if any, detected at any later stage.
