1. The DSSSB vide Result Notice No. 747 dated 13/12/18, Result Notice No. 793 dated 17/06/2019 and has provisionally selected 23 and 02 respectively for the Post of Junior Stenographer (English) in the NDMC under Post Code 47/12.

2. The One Tier Written Examination held on 11/06/2017 and the skill test was conducted as a combined examination for the post codes 211/14, 47/12 and 152/14 of shortlisted candidates on 08/02/2018 to 11/02/2018.

3. User Department, i.e., New Delhi Municipal Corporation has returned 11 Dossiers (UR-06, OBC-05) on the grounds that candidates have not responded/Joined/not found suitable to the post of Junior Stenographer (English). The dossiers/cancellation cases have been returned before the expiry of waitlist panel. Hence the Board is declaring the result of Panel/Waitlisted Candidates as per their merit, as per details below:-

The Selection of the above 06 candidates (UR-06) shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of the advertisement inviting application and subject to thorough verification of their identity with reference to their photographs, signature/handwriting, etc. on the application form, admission certificate, etc. The Candidature of the above candidates are liable to be cancelled by the user department also, in case the candidates are found not to be fulfilling the terms and conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his/her eligibility as laid down in the Recruitment Rules and after verification of the correctness of the information furnished in the application form and the documents related to education qualification, age and other essential certificates as per Government of India instructions issued in this regards vide **MHA OM No. 2/29/54-RPS, 19/11/54.**

5. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his/her eligibility as laid down in the Recruitment Rules and after verification of the correctness of the information furnished in the application form and the documents related to education qualification, age and other essential certificates as per Government of India instructions issued in this regards vide **MHA OM No. 2/29/54-RPS, 19/11/54.**

6. **The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.**

7. There is **no waiting panel in OBC category** therefore, vacancy arose due to five returned dossier could not be filled up by the board.

8. The result is subject to the outcome of the court cases pending in various courts related to this post.

9. The Wait List panel of the candidates was valid up to 12/12/2019.
