- 4. Since documents have not been called from the candidates along-with the application forms as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of name in the list of candidates qualifying for appearing in Tier-II examination does not entitled them any right over the post.

Reserved category candidates who have obtained marks above or equal to last shortlisted UR candidates have been shortlisted against UR vacancies and their final selection to the post shall be considered in UR category, subject to availability of vacancies, otherwise for selection in their respective category.
- 6. As per the Board Notice dated 26/04/2013, the minimum qualifying marks in One Tier written examination for UR category candidate is 40%, for OBC candidate is 35% and for SC/ST/PH is 30%.
- 7. The shortlisted candidates for the above mentioned post code will be informed separately for appearing in the Tier-II written examination shortly.
- **8.** While every care has been taken in preparing the list of shortlisted candidates for Tier-II examination, DSSSB reserves the right to rectify errors and omissions if any, detected at any stage.
