## NOTICE

## ASSTT. GRADE-III IN DELHI TRANSCO LIMITED POST CODE-57/13.

The DSSSB vide its advertisement No. 03/2013 had advertised 38 {UR-02, OBC-27, ST-09 including PH (OH)-01} for the post of Asstt. Grade-III, Post Code-57/13 in Delhi Transco Limited. A written examination was held on 24.09.2017. The marks statement of the above Post/Post Code has already been uploaded in the candidate's account in OARS module on <a href="https://www.dsssbonline.nic.in">www.dsssbonline.nic.in</a> for information of the candidates. Further, as per Recruitment Rules and clarification provided by the user department, a computer based skill test of the qualified shortlisted candidates was held w.e.f. 04.01.2019, 05.01.2019 & 06.01.2019.

- 2. Further, on the basis of qualifying of the skill test, the candidates had been shortlisted for uploading of documents in the e-dossier out of which 27 candidates [(UR-02, OBC-23, ST-04 including 01 PH (OH)] were provisionally nominated vide Result Notice No. 546 dated 25.11.2019. However, due to non-availability of the qualified candidates in skill test, 09 vacancies (OBC-04, ST-05) could not be filled up even after taking all the candidates who qualified in skill test held on 04.01.2019, 05.01.2019 & 06.01.2019.
- 3. Therefore, to fill up the remaining vacancies in OBC & ST category, it was decided to conduct a skill test/Typing test of the qualified candidates of written examination dated 24.09.2017 below the last shortlisted candidate under OBC & ST category as the qualified candidates are still available in respective categories. Accordingly, the merit has been lowered to conduct the skill test /typing test in ratio of 1:10 subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their application form. The shortlisted candidates shall be called for skill test/Typing Test separately:-
- **4.** The category wise cutoff marks for these two categories for skill test/typing test have been given as under:-

Category	OBC	ST
Cutoff marks	102.00	65.50
(marks obtained in written examination)		

- 5. Only those candidates have been considered in OBC category who has declared in their application form that they had obtained their caste certificates from Delhi State to the effect that their caste has been recognized as backward caste by GNCT of Delhi.
- 6. Since documents have not been called from the candidates along with the application forms as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of names in the list of candidates qualifying for appearing in Skill Test/Typing Test does not entitled them any right over the post.

Month

As per the Board notice dated 26.04.2013, the minimum qualifying marks in one Tier written examination for General candidate is 40%; for OBC candidate 35%, for SC/ST/PH is 30%. Ex-servicemen will be given 5% relaxation in their respective categories subject to a minimum of 30%.

- 8. The qualified candidates for appearing in Skill Test/Typing Test have been called in the ratio of 1:10 of the advertised vacancies; however all the candidates who have score marks equal to the cutoff marks in each category have been shortlisted.
- **9.** While every care has been taken in preparing the list of shortlisted candidates for skill test/typewriting test, DSSSB reserves the right to rectify errors and omissions if any, detected at any stage.
- 10. The above shortlisting candidates for Skill Test/Typewriting test to the post of Assistant Grade-III under post code-57/13 in DTL is subject to outcome of pending court case, if any.
