**TGT (NATURAL SCIENCE) FEMALE POST CODE-11/13 IN DIRECTORATE OF EDUCATION**

The DSSSB vide its advertisement No. 01/2013 had advertised total **186 [UR-80, OBC-20, SC-55, ST-31, including PH (OH-03)]** vacancies for the post of **TGT (Natural Science) Female, Post Code-11/13 in Directorate of Education** with closing date as **20.03.2013**. Tier-I examination in offline examination mode was conducted on **28/12/2014**.

2. On the basis of offline examination of Tier-1 held on **28.12.2014** and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.01/2013 and RRs for the post of **TGT (Natural Science) Female, Post Code-11/13** in Directorate of Education, a total of **79 (UR-56, OBC-03, SC-18, ST-02)** candidates were provisionally nominated for the post of **TGT (Natural Science) Female, Post Code-11/13** vide Result Notice No. **57** dated **03.08.2016** and 28 candidates were kept pending for want of requisite documents. Out of these 28 pending candidates, a total of **13 (UR-10, SC-02, ST-01, including 01 PH)** candidates were nominated vide Result Notice No. **91** dated **07.10.2016**, **01** candidate under SC category was nominated vide Result Notice No. **112** dated **24.01.2017**, **14 candidates (UR-09, OBC-05)** were nominated vide Result Notice No. **131** dated **24.03.2017**. Further, an opportunity was also given to 19 candidates for verification of documents who failed to submit their documents in time as they were still in consideration zone in their respective category. Out of these 19 candidates, a total of 14 candidates (UR-06, OBC-08) were nominated vide Result Notice No. **168** dated **16.08.2017** and 05 candidates were kept pending for want of requisite documents. In addition to this, in compliance of the direction of the Hon'ble CAT in O.A. No. 3602/2018, **01 candidate** under SC category was also nominated vide Supplementary Result Notice No. **502** dated **04.09.2019**.

3. Out of 05 candidates who were kept pending vide Result Notice No. 168 dated 16.08.2017, a total of 04 candidates (UR-01, OBC-03) were nominated vide Supplementary Result Notice No. **535** dated **17.10.2019** and the candidature of **01 candidate** under OBC category was kept pending for want of deficient documents. This candidate has now provided the requisite document and is found eligible in her respective category.

4. Accordingly, in continuation to Result Notice No. 57 dated 03.08.2016, Result Notice No. 91 dated 07.10.2016, Result Notice No. 112 dated 24.01.2017, Result Notice No. 131 dated 24.03.2017, Result Notice No. 168 dated 16.08.2017, Result Notice No. 502 dated 04.09.2019 & Supplementary Result Notice No. 537 dated 17.10.2019, the candidate, as detailed below, is also provisionally selected on the basis of offline examination of Tier-1 held on 28.12.2014 and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.01/2013 and RRs for the post of **TGT (Natural Science) Female, Post Code-11/13** in Directorate of Education.

5. The selection of the above 01 candidate shall further be subject to genuineness of the documents on the basis of which she has claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of her identity with reference to her photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidate is liable to be cancelled by the User Department also, in case the candidates are found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.

6. The user department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department i.e. Directorate of Education shall verify the genuineness of the Caste Certificates furnished by the candidates prior to issuing offer of appointment to the candidates. The Competent Authority of the user department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny /correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.

7. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the Competent Authority prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.

8. The User Department shall also get the SC/ST/OBC/PH/ExSM/etc. certificates verified from the Issuing authority. Further, if applicable, User Department shall also verify the genuineness of the caste certificates furnished by the candidates prior to issuing offer of



appointment to the candidates. In case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, **DoPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2009 and O.M. No. 36033/1/2013-Estt. (Res) dated 27.05.2013.**

8. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application form and e-dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential Certificates as per instructions issued by Govt. of India in this regard vide **MHA O.M. No. 2/29/54-RPS, 19-11-54.**

9. **The user department shall ensure that the appointment made is in conformity with DoPT guidelines and instructions of Govt. issued from time to time.**

10. The result process for the above post code stands closed in all respect.

11. Waiting panel for the post code-11/13 has already been expired on 02.08.2017 as per result notice no. 57 dated 03.08.2016.

12. Mere inclusion of name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.
