LIBRARIAN (SPECIAL DRIVE FOR PHYSICALLY DISABLED PERSONS), POST CODE-206/14 IN DIRECTORATE OF EDUCATION.

The DSSSB vide its advertisement No. 02/2014 dated 12/12/2014 had advertised total 09 [PH (OH)-01, (HH-08)] vacancies for the post of Librarian (Special Drive for Physically Disabled Persons) Post Code-206/14 in Directorate of Education with closing date as 25.01.2015. Tier-I examination in offline written examination mode was conducted on 04/08/2019.

- 2. All 28 candidates who had appeared in written examination were informed through notice No. F. No. 207/Result/Librarian/Int. Cell/DSSSB/2018-19/5176-85 dated 14/11/2019 on the Board's website i.e. www.dsssb.delhi.gov.in that their marks for the examination dated 04/08/2019 for the post of Librarian (Special Drive for Physically Disabled Persons) Post Code-206/14 have been declared and the same were available in their account in OARS module. Further, vide said notice, 07 shortlisted candidates who qualified the written examination were given the opportunity to upload their documents in the edossier module w.e.f. 18.11.2019 to 02.12.2019 with the specific direction that if any candidate fails to upload the e-dossier during the above said period, his/her candidature will be rejected and no further opportunity for uploading e-dossier will be given on whatsoever ground. Both the candidates have uploaded their documents in the e-dossier portal.
- 3. On the basis of marks secured in the written examination and after preliminary scrutiny as per the provisions of the statutory Recruitment Rules for the post and the terms and condition of the advertisement, the following 01 Candidate under OH category is provisionally selected for the post of Librarian (Special Drive for Physically Disabled Persons) Post Code-206/14 in Directorate of Education subject to his/her fulfilling all other conditions of eligibility and also correctness of the information furnished by the candidate in his/her online application form and e-dossier:-

4. The selection of the above 01 candidate shall further be subject to genuineness of the documents on the basis of which he/she has claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of his/her identity with reference to his/her photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidate is liable to be cancelled by the User Department also, in case the candidates are found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as down in the recruitment rules and after verification of the correctness of the information furnished in the

application form and the documents related to Educational Qualification, Age and other essential certificates.

- 5. The user department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department i.e. Directorate of Education shall verify the genuineness of the Caste Certificates furnished by the candidates prior to issuing offer of appointment to the candidates. The Competent Authority of the user department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny /correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing autghority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
- 6. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the Competent Authority prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
- 7. The User Department shall also get the SC/ST/OBC/PH/ExSM/etc. certificates verified from the Issuing authority. Further, if applicable, User Department shall also verify the genuineness of the caste certificates furnished by the candidates prior to issuing offer of appointment to the candidates. In case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DoPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2009 and O.M. No. 36033/1/2013-Estt. (Res) dated 27.05.2013.
- 8. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application form and e-dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential Certificates as per instructions issued by Govt. of India in this regard vide MHA O.M. No. 2/29/54-RPS, 19-11-54.
- 9. The user department shall ensure that the appointment made is in conformity with DoPT guidelines and instructions of Govt. issued from time to time.
- **10.** The candidature of the following 02 (two) candidates have been kept pending due to the reasons mentioned against their roll no.:-

- 11. The above pending 02 candidate i.e. having Roll No. 3340000006, 3340000002 are directed to upload their pending documents as mentioned above through the e-dossier module in w.e.f. 24/12/2019 to 02/01/2020, failing which their candidature will be rejected without any further notice.
- 12. The e-dossier link shall be activate from 24/12/2019 to 02/01/2020. The above candidate is also being separately informed through, SMS on their registered mobile number. If the candidate fails to upload required document through e-dossier during the above said period his candidature will be rejected and no further opportunity for uploading in the e-dossier will be given on whatsoever ground.
- **13.** The result process for the above post code stands closed in all respect except 02 pending case as referred above.
- 14. A waiting panel under OH category has been prepared which will be valid for a one year from the date of declaration of result i.e. upto 19/12/2020.
- 15. Mere inclusion of name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.
