

**EDUCATIONAL AND VOCATIONAL GUIDANCE COUNSELOR (FEMALE), POST CODE-149/17 IN
DIRECTORE OF EDUCATION**

In continuation of Rejection Notice No. 401 dated 05.04.2019 & Rejection Notice No. 490 dated 02/08/2019, on scrutiny of marks secured in the written examination and after preliminary scrutiny as per the provision of the statutory Recruitment Rules for the post of Educational and Vocational Guidance Counselor (Female), Post Code-149/17 in Directorate of Education and the terms and conditions of the advertisement, the candidature of the following candidates for the above mentioned post code is rejected.

The candidature of these candidates was kept pending for uploading of the deficient / requisite documents in the e-dossier for which they were given an opportunity w.e.f. **14.03.2019** to **20.03.2019** but they failed to upload the deficient documents in the e-dossier. Therefore, these candidates were given 2nd and final opportunity w.e.f. **07.08.2019 to 13.08.2019**, but they again failed to upload the deficient / requisite documents in the e-dossier. Accordingly, their candidature for the post of Educational and Vocational Guidance Counselor (Female), Post Code-149/17 has been rejected for not uploading the deficient / requisite documents in the e-dossier as mentioned against their Roll No.
