The candidature of candidate having Roll No. 20000011 in SC category is hereby cancelled as he has submitted the VH certificate having 30% invisibility whereas minimum 40% handicap is required for eligibility under PH quota and candidate having Roll No. 20013498 in OBC/DGS category is also hereby cancelled as he is working as MTS in ESI Hospital. ESIC is a Corporation (an autonomous body), hence, benefit of age relaxation is not applicable to him.
