TGT (ENGLISH) MALE, POST CODE-131/17 IN DIRECTORATE OF EDUCATION

In continuation of Rejection Notice No. 431 dated 07.05.2019, on scrutiny of marks secured in the written examination and after preliminary scrutiny as per the provision of the statutory Recruitment Rules for the post of TGT (English) Male, Post Code-131/17 in Directorate of Education and the terms and conditions of the advertisement, the candidature of the candidates bearing roll nos. mentioned below are rejected for the reason mentioned against each roll no.

2. The candidature of these candidates was kept pending vide Result Notice No. 429 dated 30.04.2019 for want of deficient / requisite documents in the e-dossier and their e-dossier were recalled by giving 1st opportunity for uploading of deficient / requisite documents w.e.f. 03.05.2019 to 12.05.2019. But these candidates failed to upload the deficient / requisite documents in the e-dossier. Further, these candidates were given 2nd and final opportunity w.e.f. 13.12.2019 to 22.12.2019 but they again failed to upload the requisite documents in the e-dossier. Therefore, on the basis of deficient documents/clarification by these candidates, they have found not eligible for the post of TGT (English) Male Post Code-131/17 in Directorate of Education:-

The said NOC has been issued after cutoff date i.e. after 31.01.2018.
		The candidate was given an opportunity w.e.f. 03.05.2019 to 12.05.2019 to upload the copy of discharge book/ PPO but he did not upload the requisite documents. He was again given 2 nd and final opportunity w.e.f. 13.12.2019 to 22.12.2019 to upload the requisite documents and he now uploaded a faded documents which is not legible.
