**NOTICE**

**Subject:- Declaration of Marks of offline examination held on 29.09.2019 for the Post of Manager (Managerial Service Cadre) in DSCSC under Post Code-59/15 – regarding.**

The DSSSB vide its advertisement No. 01/2015 had advertised **03 {UR-02, OBC-01,}** for the post **Manager (Managerial Service Cadre) in DSCSC under Post Code-59/15**. Offline Tier-I written examination was held on 29.09.2019.

2. The marks obtained by **126 candidates** who duly appeared in examination conducted (**offline mode**) on **29.09.2019** have been uploaded. Candidates can view their marks by logging into their account in OARS module on [www.dsssonline.nic.in](http://www.dsssonline.nic.in).

3. Based on the performance in Tier-I written examination, 28 candidates as informed in their OARS module have been provisionally shortlisted to appear in Tier-II examination subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application forms. The shortlisted candidates shall be called for Tier-II examination separately.

4. Since documents have not been called from the candidates along-with the application forms as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of name in the list of candidates qualifying for appearing in Tier-II examination does not entitled them any right over the post.

5. Reserved category candidates who have obtained marks above or equal to last shortlisted UR candidates have been shortlisted against UR vacancies and their final selection to the post shall be considered in UR category, subject to availability of vacancies, otherwise for selection in their respective category.

6. As per the Board notice dated 26.04.2013, the minimum qualifying marks in one Tier written examination for different categories are as under:-

UR/General : 40%;  
OBC : 35%;  
SC/ST/PH : 30%.

Ex-Servicemen : will be given 5% relaxation in their respective categories subject to a minimum of 30%

7. **The shortlisted candidates for the above mentioned post code will be informed separately for appearing in the Tier-II written examination shortly.**



8. While every care has been taken in preparing the list of shortlisted candidates for Tier-II examination, DSSSB reserves the right to rectify errors and omissions if any, detected at any stage.

9. The above shortlisting candidates for Tier-II examination to the post of Manager (Managerial Service Cadre) under post code-59/15 in DSCSC is subject to outcome of pending court case, if any.
