The shortlisted candidates for the above mentioned post code are hereby informed to fill the e-dossier and upload all the documents of Educational/Professional Certificates/Degree and Mark sheets/Caste Certificate/Disability certificate/Proof of Govt. Servant/Ex. Servicemen/Admit Cards etc., as applicable in the E-dossier module in OARS link in their individual account in OARS module. Short listing is being made on the basis of marks obtained in Tier-I written examination (Objective-MCQ) for 200 marks.
- **5.** Kindly note that the e-dossier link will be activated to only those candidates who are in the consideration zone of selection.
- **6.** The candidates who have been shortlisted for falling in the consideration zone of selection MUST upload their all requisite / applicable documents in the said link in stipulated time.
