CORRIGENDUM TO NOTICE DATED 14.11.2023

This is with reference to notice dated 14.11.2023 regarding declaration of Marks of online examination (Tier-I) held on 22.06.2022 for the Post Junior Engineer (Electrical)/Section Officer (Electrical) in various Department & Candidates shortlisted for appearing in Tier-II written examination.

The Board vide advertisement No. 02/22 had advertised 116 vacancies (UR-40, EWS-21, OBC-34, SC-14, ST-07 including 01 PwD) under combined examination scheme for the post of Junior Engineer (Electrical) or Section Officer (Electrical) under Post Code-802/22 in various departments. Further, vide notice No. 162-169 dated 03.02.2022, Notice-cum-addendum No. 935-940 dated 02.03.2023, corrigendum No. 2030-37 dated 07.08.2023 & corrigendum No. 2038-43 dated 07.08.2023, the vacancies of post code-802/22 issued under advt. no. 02/22 have been revised as 118 vacancies (UR-41, EWS-21, OBC-35, SC-14, ST-07 including PwD(OH)-03, PwD(HH-08), PwD(MD)-01, ExSM-01).

- 2. The Tier-I examination in online mode was held on 22.06.2022 under combined examination scheme and the marks obtained by 6417 candidates who duly appeared in Tier-I examination for the Post Junior Engineer (Electrical)/Section Officer (Electrical) in various departments have been uploaded on OARs module by notice dated 14.11.2023.
- 3. Now, as per corrigendum dated 25.01.2024 issued by the Board on the basis of request letter dated 13.11.2023 of Delhi Transco Limited (DTL) wherein DTL has revised its vacancies of EWS category from 12 to 03 resulting reduction of total vacancies in DTL from 37 to 28 as per details given below:-

Whereas as per prescribed ratio for shortlisting of candidates for Tier-II examination, the candidates were shortlisted as per vacancies notified earlier and after revision of vacancies by the DTL, the number of vacancies has been reduced in EWS category resulted the number of shortlisted candidates are reduced as per policy/prescribed ratio.

Accordingly, the candidatures of 08 EWS category candidates bearing Roll No. 113380202349, 121180201866, 113380201995, 121180200248, 113480200330, 112580200901, 112580200337, 121180201141 who were earlier shortlisted for appearing in Tier-II examination vide notice dated 14.11.2023 is withdrawn being lower in merit as the number of shortlisted candidates have been reduced as per policy/prescribed ratio of the Board.
- 6. Further, due to reduction in vacancies vide corrigendum dated 25.01.2024, the revised cutoff marks of shortlisted candidates for appearing in Tier-II examination is as under:-
