RESULT NOTICE NO. 1474 PGT URDU (MALE) UNDER POST CODE 155/12 DIRECTORATE OF EDUCATION, GNCTD

- The DSSSB vide its advertisement no. 02/2012 with closing date 15.06.2012 had advertised 01 (UR-01) vacancy for the post of PGT URDU (Male) under Post Code 155/12 in Directorate of Education, GNCTD.
- 2. The Tier-I & Tier-II examination for recruitment in respect of this post was conducted on 30.11.2014 & 28.06.2015 respectively.
- Sh. Mohd. Vaquar Khan (Roll No. 38000037), a candidate filed O.A. No. 4393/2018 titled as Mohd. Vaquar Khan Vs GNCTD & Ors. Ld. Central Administrative Tribunal vide its order dated 16.05.2023 disposed of the said O.A. with the following directions:

"5. Conclusion

- 5.1 In view of the above discussion, we set aside the decision of the respondents in cancelling the wait list panel as on 30.06.2018. The applicant, whose name was figuring the Reserve Panel/Wait List,, shall be sent offer of appointment, if otherwise found eligible/suitable, within eight weeks from the date of receipt of a certified copy of this order. He shall be given consequential benefits only on a notional basis with reference to his batchmates as per his merit position.
- 5.2 The OA is allowed in aforesaid terms."
- 4. Further, the Hon'ble High Court vide its Order dated 18/03/2024 dismissed the WP (C) 4021/2024 titled as DSSSB vs. Mohd. Vaquar Khan, filed by DSSSB.
- 5. In the light of the order of Hon'ble High Court of Delhi & Ld. Tribunal and as per the policy of the Board, the shortlisted candidates having roll no. 38000017 and 38000037 for the post code 155/12 were given opportunity through notice no. 1448 dated 03/01/2024 and 1447 dated 03/01/2024 respectively to submit/provide the requisite documents/dossiers within stipulated time frame. In response to the Notice No. 1448 dated 03/01/2024, the candidate having roll no. 38000017 failed to provide the requisite documents/dossiers, therefore, the candidature of the candidate having roll no. 38000017 is hereby cancelled. In response to the Notice No. 1447 dated 03/01/2024, the candidate having roll no. 38000037 has provided the requisite documents/dossiers.
- On the basis of the merit, the candidate having following roll number is hereby provisionally nominated, in compliance of the order dated 16/05/2023 of Ld. Tribunal, for the post of PGT

Urdu (Male) under post code 155/12 in Directorate of Education, subject to fulfilling all conditions of eligibility and also correctness of the information furnished by the candidate in the application form and dossier:

- 7. As per the Board's resolution dated 14/07/2022 and as per decision of the Board dated 20/01/2023, no scrutiny of documents in the dossier and of the other terms and conditions of recruitment notified by the Board in the advertisement of the said post code has been done by the Board. The eligibility as per Recruitment Rules and other terms and condition as specified in the advertisement in the advertisement No. 02/2012 and relaxations as per rules in respect of educational qualifications, experience, other certificates shall be scrutinized/verified by the User Department for determining eligibility of the candidate for the Post Code 155/12 as on cutoff date 15.06.2012 before issuance of offer of appointment to the post.
- 8. The provisional nomination of the above 01 candidate (UR-01) shall be further subject to thorough verification of candidature of the candidate by the User Department including the identity of the candidate.
- 9. The provisional nomination of the above candidate shall further be subject to genuineness of the documents on the basis of which he has claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of the advertisement inviting application and subject to thorough verification of his identity with reference to his photograph, signature/handwriting, etc. on the application form, admission certificate, etc. The Candidature of the above candidate is liable to be cancelled by the User Department in case the candidate is found not to be fulfilling the terms and conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidate after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.
- 10. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally nominated candidate. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
- 11. The Competent Authority of the Department concerned shall issue the appointment letters to the candidate after being satisfied about his eligibility as laid down in the Recruitment Rules

and after verification of the correctness of the information furnished in the application form and the documents related to education qualification, age and other essential certificates as per Government of India instructions issued in this regards vide MHA OM No. 2/29/54-RPS, 19/11/54.

- 12. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
- 13. Mere inclusion of the name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.
- 14. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
- 15. The result is subject to the outcome of the court cases, if any, pending in various courts related to this post.
- 16. There is no waitlist panel in this post code and the selection process for the post code 155/12 stands closed.
- 17. The category wise marks scored by the last provisionally nominated candidate is as under:-
