- This is continuation of Result Notice No. 1477 Dated 02.08.2022 & 1486 dated 20.09.2022.
- DSSSB vide Result Notice No. 1477 dated 02.08.2022 provisionally nominated Total 556 Candidates [EWS-26 (including PH-OH-EWS-01), UR-329 (Including PH-OH-UR-10 & PH-VH-UR-08), OBC-163 (Including PH-VH-OBC-01), SC-25 (Including PH-OH-UR-01 & PH-VH-UR-01) & ST-13] and waiting panel of total 95 Candidates vide Result Notice No. 1477 dated 02.08.2022 & result Notice No. 1486 dated 20.09.2022 [EWS-06, UR-66, OBC- 09+01=10, SC-05, ST-03 & PH-VH-03 & PH-OH-02) for the Post of TGT (Hindi) Male under Post Code-34/21 in Directorate of Education subject to their fulfilling all other conditions of eligibility and correctness of information furnished by the candidate in their online applicant form and e-dossier.
- 3. The User Department vide their letter dt. 26.07.2023 has informed that all the nominated and waitlisted candidates under above Category have been utilized and requested to provide additional eligible candidates from the reserve panel of above category under post code 34/21 following the clarification of User Department vide its letter dated 16.04.2024.
- 4. The validity of the reserve panel of post code 34/21 was **valid up to 01.08.2023** and the returned dossiers along with complete status report were received from Directorate of Education prior to expiry of waitlist panel, hence, as per Board's resolution dated 19th May, 2021 in supersession of earlier policy dated 13 June 2019 and in accordance with Services Department Circular No. F.16(3)/DSSSB/2007-S-III/1756-1763 dated 02/08/2021, out of the waiting/reserve panel comprising all the candidates above minimum qualifying marks in Written Examination, **the following additional total 34 waitlisted candidates are hereby provisionally nominated from reserve panel of UR- 22, EWS- 11 & SC-01 Categories under post code 34/21** purely on the basis of marks obtained by the candidates in the examination held on Online Exam conducted on 18.09.2021, as per Board's resolution dated 14/07/2022 with a request to the User Department to utilize the same, in conformity with DOPT guidelines and instructions of Govt. of NCT, Delhi issued from time to time and also mentioned in the Result Notice No. 1477 dated 02.08.2022.

Note: User Department has requested to provide total 54 candidates in OBC Category substitutes against the cancellation of candidature in OBC Category, but as per our record, No reserve panel maintained due to no suitable candidate found in OBC category. Therefore, total 54 candidates returned to user department as unfilled.

- 5. The provisionally nomination of additional waitlisted 34 candidates (nominated from reserve panel) of UR- 22, EWS- 11 & SC-01 has been processed purely on the basis of marks obtained by the candidates in the examination held on Online Exam conducted on 18.09.2021 and also claims made by the candidates in their online application forms of the post code 34/21 for the post of TGT (Hindi) Male in Directorate of Education. As per the Board's resolution dated 14/07/2022 and as per decision of the Board dated 20/01/2023, the Board has not undertaken scrutiny of documents uploaded in the e-dossiers and other terms and conditions of recruitment notified by the Board in the advertisement of the said post code at this stage. The eligibility as per Recruitment Rules and other terms and conditions as specified in the advertisement no. 02/21 and relaxations as per rules in respect of educational qualifications, experience, etc. shall be scrutinized/verified by the User Department for determining eligibility of the candidate for the post code 34/21 as on cut-off date 24.06.2021 before issuance of offer of appointment to the post.
- 6. The category wise marks scored by the last provisionally nominated candidate of reserve panel are is as under:

7. The result process for the above post code stands closed in all respect. Waiting panel was valid for a period of one year from the date of declaration of result i.e. upto 01.08.2023 as per Main Result Notice No. 1477 dated 02/08/2022 which has been expired. The current supplementary result is

- declared against the dossiers returned by the User Department which received in the Board well before expiry of waiting panel.
- 8. The User Department, being Cadre Controlling/Appointing Authority, shall strictly follow the merit based ranking of the candidate.
- 9. The candidates in the Waiting Panel or the Balance Reserve Panel shall have no claim or right for appointment per se against the vacancies notified for the recruitment. Nomination of above candidates from Reserve Panel is on the basis of numbers of dossiers returned by the User Department within validity panel in respective categories/Sub-categories. They can only get the offer of appointment only in the event any vacancies (category-wise) arising due to non-acceptance of the offer of appointment, not joining the post after acceptance of appointment, resignation after joining, etc within one year of validity of panel.
- 10. User Department being cadre Controlling Appointment Authority shall utilize the reserve panel subject to availability of candidates in respective categories/Subcategories and purely on the basis of merit following the relevant circulars/OMs guidelines issued by the Government.
- While operating the waiting panel/reserve panel list, the User Department shall strictly follow instructions issued vide DoPT OM No. 36012/2/96-Estt. (Res) dated 02/07/1997, 36011/1/98-Estt. (Res) dated 01/07/1998 and 43011/4/2018-Estt. (Res) dated 04/04/ 2018 regarding shifting of candidates from respective reserve categories to the un-reserve category.
- 12. The user department shall operate the waiting panel up to the number of vacancies notified under each category by the DSSSB in its advertisement and not beyond it even by taking any type of relaxation from any authority as it shall rendered the excess appointment void and illegal *Ab initio*.
- 13. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
- 14. Wherever the Court has directed to not declare result without leave of the court such cases will be dealt separately, if falling in main result/proposed 20% waiting panel list. The user department shall decide such cases subject to outcome of court case(s).
- 15. The User Department shall also get the EWS certificates verified from the Issuing authority. Further, the User Department shall also verify the veracity of the Income and asset certificate submitted by the candidate through the certificate issuing authority as per instruction of DoPT O.M. No. 36039/1/2019-Estt (Res) dated 31.01.2019.
- 16. The result is subject to the outcome of the court cases, if any, pending in various courts related to this post.
- 17. This issues with the prior approval of the Chairman, DSSSB.
