- The DSSSB vide its advertisement No.01/23 had advertised Total- 03 vacancies (UR-03 Including PwD-01(HH-01)) for the Post of Craft Instructor-Food Production (General) (For NTC/STC/NAC Holders) in Directorate of Training and Technical Education (DTTE), GNCTD under Post code 22/23 and conducted one tier (Technical) examination (online mode) for recruitment on 16th March 2024.
- 2. The marks statement of **1 candidate** who appeared in online examination (One Tier-Technical) held on 16th March 2024 have been uploaded on Board's website. Candidate can view their marks by logging into their account in OARS module on www.dsssbonline.nic.in.
- 3. As per the Advertisement No. 01/23 dated 24.02.2023 para 5(e) the minimum qualifying marks (wherever applicable) for different categories (UR/SC/ST/OBC/EWS/PwD/Ex-SM) are as under:

General/EWS

40%

OBC(Delhi)

35%

SC/ST/PH(PwD)

30%

Ex-Servicemen will be given 5% relaxation in their respective categories subject to a minimum of 30%, if post is reserved for Ex-Servicemen.

- 4. As per the Advertisement No. 01/23 dated 24.02.2023, the mandatory minimum qualifying marks in Tier-I Examinations will be applicable only in r/o Section-B which is domain subject specific. There will not be any minimum qualifying marks in Section-A. However, combined aggregate marks of both Section A & Section-B will be reckoned for preparing the final merit list.
- 5. Based on the performance in online examination **None candidate** found qualified/suitable in UR and including PwD (HH) category. Hence, **NIL Candidate is shortlisted** for uploading of e-dossier for the post of Craft Instructor-Food Production (General) (For NTC/STC/NAC Holders) in Directorate of Training and Technical Education (DTTE), GNCTD, Post Code 22/23.
- 6.
