## Sub: Calling of E-dossier for the Post of Warder (Male) under post code 37/2013 in Delhi Prison Department

- The DSSSB vide its advertisement No. 02/2013 with closing date 02/08/2013, had advertised 528 vacancies (UR-268, OBC-142, SC-79, ST-39 out of which 53 vacancies were reserved for EXSM) for the Post of Warder (Male) under post code 37/13 in Delhi Prison Department.
- 2. That Sh. Ajit Kumar Ruhil (Roll No. 3713030093) applied for the post of Warder (Male), under Post Code 37/13) in Delhi Prison Department and appeared in Written exam on 02.03.2014.
- 3. Sh. Ajit Kumar Ruhil (Roll No. 3713030093) was disqualified in Physical Endurance Test (PET) held on 05.07.2016 as his height was measured less than the qualifying measurement i.e. 170 cms. as per Advertisement for the post of Warder (Male), under Post Code 37/13.
- 4. Sh. Ajit Kumar Ruhil (Roll No. 3713030093) filed 2622/2019 titled as Ajit Kumar Ruhil Vs DSSSB & Ors. The Ld. Tribunal disposed of the O.A. No. vide its order dated 01.04.2024, whereby Hon'ble Tribunal directed to get the remeasurement of the height of applicant. Therefore, a Medical Board was constituted in compliance of said order of Ld. Tribunal. The Medical Board constituted at Lok Nayak Hospital, (GNCTD) measured the height of Sh. Ajit Kumar (Roll No. 3713030093) as 170 cms.
- 5. Thereafter Sh. Ajit Kumar Ruhil (Roll No. 3713030093) has qualified the Physical Endurance Test conducted on 24.09.2024. Hence, Sh. Ajit Kumar (Roll No. 3713030093) is hereby declared as qualified the Physical Endurance Test for the post of Warder (Male), under Post Code 37/13) in Delhi Prison Department.
- 6. Based on the performance in the written examination and being qualified in PET, the candidate Sh. Ajit Kumar Ruhil (Roll No. 3713030093) is being provisionally shortlisted for up-loading of e-dossier subject to attaining of minimum qualifying marks and correctness of the information furnished by the candidate in his online application form.

- 7. The shortlisted candidate for the above-mentioned post/post code is hereby informed to fill the e-dossier and up-load all the documents of Educational Certificate/Professional/Experience Certificates/Degree and Marks sheets/Caste Certificate/Proof of Govt. Servant/Ex Servicemen/Admit Cards, etc., as applicable in the e-dossier module in OARS link in their individual accounts in OARS module. Shortlisting is being made on the basis of marks obtained written examination and being also qualified in PET.
- 8. The result status of the candidate is being uploaded in OARS module. Candidate can check his status by logging into his account in OARS module on <a href="https://www.dsssbonline.nic.in">www.dsssbonline.nic.in</a>.
- The candidate Sh. Ajit Kumar Ruhil (Roll No. 3713030093) who has been shortlisted for falling in consideration zone of selection MUST upload their all requisite/applicable documents in the said link in stipulated time.
- 10. The e-dossier link shall be active from 13/11/2024 to 27/11/2024. The candidate uploading e-dossier should ensure that he/she fulfills all the eligibility criteria/all essential qualifications as per RRs for the Post as on date of Closing date of application, i.e., 02/08/2013.
- The above shortlisted candidate is also being separately informed through SMS and email on their registered mobile number and e-mail ID as an additional facility. If candidate fails to upload the e-dossier during their above said period, his/her candidature will be rejected and no further opportunity will be given on whatsoever ground.
- 12. The candidate Sh. Ajit Kumar Ruhil (Roll No. 3713030093) who has shortlisted for uploading e-dossiers MUST upload their all requisite/applicable documents in the said link in stipulated time i.e. 13/11/2024 to 27/11/2024.
- 13. Mere asking the candidate for up-loading documents in the e-dossier module does not confer upon him/her any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that if the candidate fails to upload his/her documents on or before the date as mentioned above he/she will not be given any further opportunity and his candidature will be treated as cancelled.
- 14. The above short listing of candidate for calling of e-dossier for the post code -37/13 will be subject to outcome of pending court cases, if any.

- 15. While every care has been taken in preparing the list of shortlisted candidate, DSSSB reserves the right to rectify errors and omissions if any, detected at any later stage.
