The provisionally nomination of the above 01 (One) candidate (UR-01) has been processed purely on the basis of marks obtained by the candidate in the combined examination conducted on 18.12.2011 and 10.06.2012 respectively, and also claims made by the candidate in their offline application forms of the post code 32/10 for the post of PGT (Economics) in Directorate of Education. The eligibility as per Recruitment Rules and other terms and conditions as specified in the advertisement No. 002/2010 and relaxations as per rules in respect of educational qualifications, experience, etc. shall be scrutinized/verified by the User Department for determining eligibility of the candidate for the post code 32/10 as on cut-off date 30.07.2010 before issuance of offer of appointment to the post and in accordance compliance of the order dated 26.07.2024 passed by Ld. CAT of Delhi in OA No. 2836/2015 in the matter of Shabana Parveen Versus Govt. of NCT of Delhi & ORS.

The User department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidate. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally nominated candidate. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.

As per the Board's resolution dated 14/07/2022 and as per decision of the Board dated 20/01/2023, the Board has not undertaken scrutiny of documents uploaded in the

e-dossiers module and other terms and conditions of recruitment notified by the Board in the advertisement of the said post code at this stage. The eligibility as per Recruitment Rules and other terms and conditions as specified in the advertisement no. 002/2010 and relaxations as per rules in respect of educational qualifications, experience, etc. shall be scrutinized/verified by the User Department for determining eligibility of the candidate for the post code 32/10 as on cut-off date 30.07.2010 before issuance of offer of appointment to the post.
