1. The DSSSB vide its advertisement No.04/24 read with Corrigenda dated 29.11.2024, 08.07.2025 and Addendum dated 02.09.2025 had advertised **total – 02 vacancies (OBC-01 & SC-01)** for the post of **Translator (Hindi) under Post Code- 07/24 in Legislative Assembly Secretariat.**
2. The written examination (online mode) TIER-I was conducted on **21.04.2025.**
3. The normalized marks obtained by **128 candidates** who have duly appeared in written examination held on **21.04.2025** have been uploaded on Board's website. Candidates can view their marks by logging into their account in OARS module on **www.dsssbonline.nic.in**
4. Based on the performance in the Tier-I written examination (online Mode), a total of **107 candidates who obtained marks above or equal to cut-off marks in their respective categories, as detailed below, have been provisionally shortlisted to appear in Tier-II examination,** subject to the information furnished by the candidates in their online application forms. The shortlisted candidates shall be called for Tier-II examination separately.

5. **The advertised vacancies are for OBC and SC Categories exclusively.**
6. Further, since documents have not been called from the candidates along with the application forms as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of names in the list of candidates shortlisted for appearing in Tier-II Examination does not entitle them any right over the post.
7. As per the Board Policy the minimum qualifying marks in one Tier written examination for UR & EWS Category Candidate is 40%, for OBC candidate is 35% and for SC, ST & PwBD candidate is 30%.


