- The DSSSB vide its vacancy notice/Advertisement No. 05/24 dated 05/03/2024 with closing date 17/04/2024 had advertised 01 UR vacancy for the Post of Labour Officer under post code 53/24 in Delhi Transport Corporation.
- 2. The CBT Tier-I exam for recruitment for post was conducted on 28.06.2025.
- 3. As per corrigendum dated 08/07/2025 of Examination Scheme para 4, in Two Tier Technical Examination, the mandatory minimum qualifying marks will be applicable in domain subject specific i.e. Section-B and there will not be any minimum qualifying marks in Section-A. However, combined marks of both Section-A and Section-B will be reckoned for shortlisting of candidates for Tier-II Examination.
- 4. The Prorated marks obtained by 515 candidates who appeared in CBT Tier-I have been uploaded on OARS. Candidates can view their marks by logging in to their account in OARS module on www.dsssbonline.nic.in
- 5. Based on the performance in CBT Tier-I(MCQ) for 200 marks, the candidates who have secured equal or more marks in their respective category as per the details given below in the table have been provisionally shortlisted for Tier-II subject to correctness of the information furnished by the candidates in their online application forms
