**SUBJECT:-RELEASING OF MARKS OF TIER-I AND SHORTLISTING FOR SKILL TEST.**

1. The DSSSB vide its advertisement No.05/24 read with corrigendum dated 08.07.2025 had advertised **Total-05 vacancies [UR-04, OBC-01]** for the post of Field Clerk Under Post Code- 70/24 in Directorate of Civil Defence.
2. The written examination (online mode) was conducted on **24.06.2025**.
3. The marks obtained by **89 candidates** who have duly appeared in examination (online mode) held on **24.06.2025** have been uploaded on Board's website. Candidates can view their marks by logging into their account in OARS module on **www.dsssonline.nic.in**
4. Based on the performance in the Tier-I written examination (online Mode), a total of **35 candidates** who obtained marks above or equal to cut-off marks in their respective categories, as detailed below, have been provisionally shortlisted to appear in Skill Test, subject to the information furnished by the candidates in their online application forms. The shortlisted candidates shall be called for Skill Test separately.

Further, since documents have not been called from the candidates along with the application forms as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of names in the list of candidates shortlisted for appearing in Skill Test does not entitle them any right over the post.
6. As per the Board Policy the minimum qualifying marks in one Tier written examination for UR & EWS Category Candidates is 40%, for OBC candidates is 35% and for SC, ST & PwBD candidates is 30%.
7. **The details of Skill Test shall be notified separately by the Board. The candidates are advised to check the Board's website regularly.**
8. The above short-listing for Skill Test for the post of Field Clerk under Post Code- 70/24 in Directorate of Civil Defence will be subject to outcome of pending court cases, if any.

9. While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
