1. DSSSB vide Result Notice No.47 dated 11/08/2024 provisionally nominated 01 candidates (UR-1) and also provisionally nominated 01 waitlist candidate (URWL-01), as per their merit, for the post of Draftsman under post code 79/23, in DIRECTORATE GENERAL OF HOME GUARDS subject to their fulfilling all other conditions of eligibility and correctness of information furnished by the candidate in their online applicant form and e-dossier.
2. The User Department i.e. DIRECTORATE GENERAL OF HOME GUARDS, Govt. of NCT of Delhi vide letters 12518 dated 30/07/2025 has provided complete status main list and the waiting panel of UR Category along with the returned and cancelled dossiers. The User Department has informed that all the nominated and waitlisted candidates under UR Category have been utilized as cancellation of candidature and requested to provide additional 01 eligible candidate from the reserve panel of UR category under post code 79/23.
3. The validity of the reserve panel of post code 79/23 was valid up to 11/08/2025 and the returned dossiers are received in DSSSB prior to expiry of waitlist panel, hence, as per Board's resolution dated 19th May, 2021, in suppression of earlier policy dated 13 June 2019 and in accordance with Services Department Circular No. F.16(3)/DSSSB/2007-S-III/1756-1763 dated 02/08/2021, out of the waiting/reserve panel comprising all the candidates above minimum qualifying marks in Tier-I Examination, the following additional **01 candidate** is hereby provisionally nominated **from reserve panel of UR Category under post code 79/23, purely on the basis of marks obtained by the candidate in the examination held on 30/03/2024, as per Board's resolution dated 14/07/2022** with a request to the User Department to utilize the same, in conformity with DoPT guidelines and instructions of Govt. of NCT, Delhi issued from time to time and also mentioned in the result Notice No. 47 dated 11.08.2024:-

While operating the reserve panel, the User Department shall strictly follow instructions issued vide DoPT OM No. 36012/2/96-Estt. (Res) dated 02/07/1997, 36011/1/98-Estt. (Res) dated 01/07/1998 and 43011/4/2018-Estt. (Res) dated 04/04/2018 .

4. The provisionally nomination of above 01 candidate (nominated from reserve panel of UR Category) has been processed purely on the basis of marks obtained by the candidates in the examination held on 30/03/2024 and also claims made by the candidates in online application forms of the post code 79/23 for the post of Draftsman in DIRECTORATE GENERAL OF HOME GUARDS, Govt. of NCT of Delhi. As per the Board's resolution dated 14/07/2022 and as per decision of the Board dated 20/01/2023, the Board has not undertaken scrutiny of documents uploaded in the e-dossiers and other terms and conditions of recruitment notified by the Board in the advertisement of the said post code at this stage. The eligibility as per Recruitment Rules and other terms and conditions as specified in the advertisement no. 03/23 and relaxations as per rules in respect of educational qualifications, experience, etc. shall be scrutinized/verified by the User Department for determining eligibility of the candidate for the post code 79/23 as on cutoff date 20/12/2023 before issuance of offer of appointment to the post.
5. The category wise marks scored by the last provisionally nominated candidate of reserve panel of UR Category is as under:-

6. The User Department, being Cadre Controlling/Appointing Authority, shall strictly follow the merit based ranking of the candidate.
7. The candidates in the Waiting Panel or the Balance Reserve Panel shall have no claim or right for appointment perse against the vacancies notified for the recruitment. They can only get the offer of appointment only in the event any vacancies (category-wise) arising due to non-acceptance of the offer of appointment, not joining the post after acceptance of appointment, resignation after joining, etc within one year of validity of panel.
8. The user department shall operate the waiting panel up to the number of vacancies notified under each category by the DSSSB in its advertisement and not beyond it even by taking any type of relaxation from any authority as it shall rendered the excess appointment void and illegal *Ab initio*.

9. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
10. The result is subject to the outcome of the court cases, if any, pending in various courts related to this post.


