## **SUPPLEMENTARY RESULT NOTICE NO: 189**

## Post Code-10/20, for the post of Legal Assistant, in Delhi Transport Corporation

- 1. The DSSSB vide its Advt. No.01/20 dated 01.01.2020 had advertised total 04 (UR-03, OBC-01) vacancy for the post of Legal Assistant in DTC, Post code -10/20 with closing date as 06.02.2020. Tier-I examination in online mode was conducted on 17.10.2021.
- 2. On the basis of marks secured in the written examination and after preliminary scrutiny as per the provisions of the Statutory Recruitment Rules for the post and the terms and condition of the advertisement, **04 Candidates (UR- 03 & OBC-01)** provisionally and **02 (UR-1 & OBC-1)** in wait list panel were selected for the post of Legal Assistant Post Code-10/20 In Delhi Transport Corporation. Further, due to return of all e-dossiers (Total 06- UR-04 and OBC-02 including waitlist candidates) by the User Department, all 04 vacancies are arisen against return of dossiers. In continuation of Result Notice No. 119 dated 23.03.2022, Supplementary Result Notice no. 183 dated 12.04.2023 was issued by DSSSB to invite e-dossiers online from qualified shortlisted candidates from reserve panel by lowering the merit. Therefore, to fill up 04 vacancies (UR-03, OBC-01) the candidates below the merit of last shortlisted candidate were shortlisted for uploading of e-dossier w.e.f. 18.04.2023 to 02.05.2023 vide notice No. 183 dated 12.04.2023.
- 3. Three provisionally selected candidates (UR-2 & OBC-1), whose candidature was cancelled by DTC moved to Hon'ble CAT and challenged the cancellation of candidature order of DTC. In pursuance of Hon'ble CAT Judgement dated 22.3.2023 in OA 130/2023 and as per letter from DTC dated 20.4.2023, the original dossiers of these three candidates (UR-2 & OBC-1) have been returned to DTC. Hence, only one (01) vacancy in UR category is to be filled up.
- 4. The dossiers uploaded by shortlisted candidates against notice no. 183 dated 12.4.2023 are now not taken into consideration due to afore mentioned Hon'ble CAT order dated 22.3.2023 and as the dossier for one remaining vacancy of UR is already available with DSSSB in wait list panel/reserve panel.
- 5. The candidate, as detailed below is also provisionally nominated purely on the basis of marks obtained by the candidate in the online examination of Tier-I held on 17/10/2021 and also claims made by the candidates in their online application forms of the post code-10/20 for the post of **Legal Assistant in Delhi Transport Corporation**, **GNCTD**. The eligibility as per Recruitment Rules and other terms and conditions as specified in the Advertisement No. 01/20 and relaxations as per rules in respect of educational qualifications, age, experience, etc. shall be scrutinized / verified by the User Department for determining eligibility of the candidates for the post code-10/20 as on cutoff date 06.02.2020 before issuance of offer of appointment to the post.
- 6. On the basis of marks secured in the written examination and considering other relaxations, if any, claimed by the candidates in their online application forms, total **01** candidate (UR-01) having following roll number is hereby provisionally nominated for the post of Legal Assistant, Post Code-10/20 in Delhi Transport Corporation subject to fulfilling all other conditions of eligibility and also correctness of the information furnished by the candidate in their online application forms and e-dossier:-

7. The provisional nomination of the above **total-01 (UR-01)** candidate on the basis of his claim in his application / documents submitted in E-dossier shall be subject to thorough verification of the candidature of the candidate by the User Department including the identity of the candidates as per Services Department, GNCTD. Circular No. F.16(3)/2007/S-III/1756-1763 dated 02.08.2021.

- 8. The provisional nomination of the above 01 candidate (UR-01) shall further be subject to genuineness of the documents on the basis of which his/her has claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of his/her identity with reference to his/her photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidate is liable to be cancelled by the User Department also, in case the candidate is found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidate after being satisfied about his/her eligibility as laid down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.
- 9. The user department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department shall verify the genuineness of the Caste Certificates furnished by the candidate prior to issuing offer of appointment to the candidate. The Competent Authority of the user department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny /correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
- 10. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the Competent Authority prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
- 11. The User Department shall also get the SC/ST/OBC/PH/ExSM/etc. certificates verified from the Issuing authority. Further, if applicable, User Department shall also verify the genuineness of the caste certificates furnished by the candidates prior to issuing offer of appointment to the candidates. In case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DoPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2009 and O.M. No. 36033/1/2013-Estt. (Res) dated 27.05.2013 & 13.09.2017.
- 12. Further, in case of EWS candidate, if any, it may also be verified that the validity of EWS Certificate should be as per DoPT OM No. 36039/1/2019-ESTT(Res) dated 31.01.2019 and other instructions / guidelines issued from time to time in this regard by the Competent Authorities.
- 13. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application form and e-dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential Certificates as per instructions issued by Govt. of India in this regard vide MHA O.M. No. 2/29/54-RPS, 19-11-54.
- 14. The user department shall ensure that the appointment made is in conformity with DoPT guidelines and instructions of Govt. issued from time to time.
- 15. Mere inclusion of name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.
