# ASSISTANT TEACHER (NURSERY), POST CODE-16/19 IN DIRECTORATE OF EDUCATION

The DSSSB vide its advertisement No. 03/19 dated 05.09.2019 had advertised total 141 [EWS-8, UR-77, OBC-26, SC-21, ST-09 including PH-11] vacancy for the post of Assistant Teacher (Nursery) in Directorate of Education, Post Code-16/19 with closing date as 15/10/2019. Further, vide addendum to advertisement no. 03/20019 for post code-16/19 dated 15/11/2019, the vacancies of the aforesaid post code had been revised as 265 (UR-128, EWS-20, OBC-73, SC-21, ST-23 including PH/OH-05, PH/VH-09) and thereafter, vide corrigendum dated 24.09.2020, the number of vacancies have been revised as 265 (UR-122, EWS-26, OBC-73, SC-21, ST-23 including PH/OH-05, PH/VH-09). Tier-I examination in online mode was conducted on 19/11/2019.

- 2. On the basis of marks secured in the written examination and after preliminary scrutiny as per the provisions of the statutory Recruitment Rules for the post and the terms and condition of the advertisement, a total 138 Candidates [(UR- 59, EWS-15, OBC-43, SC-12, ST-09 including 09 PH (OH), PH(VH)] were provisionally selected for the post of Assistant Teacher (Nursery), Post Code-16/19 in Directorate of Education and 115 Candidates [(UR- 57, EWS-08, OBC-33, SC-11, ST-06 including 03 PH] were provisionally nominated vide Supplementary Result Notice No. 805 dated 16.08.2021 Further, due to return of e-dossiers by the User Department, some vacancies were created against which 30 candidates (UR-08, EWS-07, OBC-09, SC-06 including 01 PH/OH) were provisionally nominated vide Supplementary Result Notice No. 834 dated 31.03.2022 and further 01 candidate under UR category was provisionally nominated vide Supplementary Result Notice No. 842 dated 22.04.2022. However, 44 vacancies were still remained unfilled against return dossiers and vacancies kept pending earlier. Therefore, to fill up these 44 vacancies, 104 qualified candidates in their respective category below the merit of last shortlisted candidate were shortlisted for uploading of edossier w.e.f. 06.05.2022 to 20.05.2022 vide notice dated 04.05.2022.
- 3. Accordingly, in continuation of Result Notice No. 706 dated 19.11.2020, Supplementary Result Notice No. 805 dated 16.08.2021, Supplementary Result Notice No. 834 dated 31.03.2022 & Supplementary Result Notice No. 842 dated 22.04.2022, the candidates, as detailed below, are also provisionally nominated purely on the basis of marks obtained by the candidate in the online examination of Tier-I held on 19/11/2019 and also claims made by the candidate in their online application forms of the post code-16/19 for the post of Assistant Teacher (Nursery) in Directorate of Education, GNCTD. The Board has not undertaken scrutiny of documents uploaded in the e-dossiers at this stage, as per Board's resolution / decision dated 14.07.2022. The eligibility as per Recruitment Rules and other terms and conditions as specified in the Advertisement No. 03/19 and relaxations as per rules in respect of educational qualifications, age, experience, etc. shall be scrutinized / verified by the User Department for determining eligibility of the candidates for the post code-16/19 as on cutoff date 15.10.2019 before issuance of offer of appointment to the post.



4. On the basis of marks secured in the written examination and considering other relaxations, if any, claimed by the candidates in their online application forms, total 43 candidates (UR-23 including 02 PH/OH, OBC-05, SC-03, ST-12) having following roll numbers are hereby provisionally nominated for the post of Assistant Teacher (Nursery), Post Code-16/19 in Directorate of Education subject to their fulfilling all other conditions of eligibility and also correctness of the information furnished by the candidate in their online application forms and e-dossier:-

Further, Roll No. 11161500656, 11301500185 were nominated under SC category vide supplementary result notice no. 805 dated 16.08.2021. As the merit of UR category has become lower due to return of dossiers by the User Department, the candidature of these candidates are falling under UR category, hence, these candidates have been shifted to UR category as per own merit candidate. The User Department is requested to modify their results accordingly.

However, this vacancy is adjusted against PH/VH (visually impaired) category in accordance with addendum to Advertisement Number 03/2019 for post code-16/19 issued vide No. F. 4 (347)/P&P/DSSSB/19/3099 dated 15/11/2019 that "in case the candidates from VI in PH category is not available, then the vacancies may be filled amongst the candidates from OH (locomotor disability) PH category".

- 5. The user department is requested to thoroughly verify the certificates of Nursery Teacher's Training course uploaded by the candidates in the light of National Council for Teachers Education's instructions/guidelines issued from time to time before issuance of any offer of appointment. The user department is further requested that if the candidate found not eligible, his/her dossier may be returned after cancellation of his/her candidature.
- 6. The selection of the above 43 candidates (UR-23 including 02 PH/OH, OBC-05, SC-03, ST-12) candidates shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidates are liable to be cancelled by the User Department also, in case the candidates are found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as laid down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.
- 7. The user department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department shall verify the genuineness of the Caste Certificates furnished by the candidate prior to issuing offer of appointment to the candidate. The Competent Authority of the user department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny /correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.



- 8. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the Competent Authority prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
- 9. The User Department shall also get the SC/ST/OBC/PH/ExSM/etc. certificates verified from the Issuing authority. Further, if applicable, User Department shall also verify the genuineness of the caste certificates furnished by the candidates prior to issuing offer of appointment to the candidates. In case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DoPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2009 and O.M. No. 36033/1/2013-Estt. (Res) dated 27.05.2013 & 13.09.2017.
- 10. The User Department shall also get the EWS certificates verified from the Issuing authority. Further, the User Department shall also verify the veracity of the Income and asset certificate submitted by the candidate through the certificate issuing authority as per instruction of DoPT O.M. No. 36039/1/2019-Estt (Res) dated 31.01.2019.
- 11. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application form and e-dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential Certificates as per instructions issued by Govt. of India in this regard vide MHA O.M. No. 2/29/54-RPS, 19-11-54.
- 12. The user department is further requested to ascertain the eligibility condition with regard to one time age relaxation to the Guest/Contract Teachers of Directorate of Education in pursuance of services O.M. No. F19 (11)/2015/S-IV/1751-1756 dated 11.06.2019.
- 13. The user department shall ensure that the appointment made is in conformity with DoPT guidelines and instructions of Govt. issued from time to time.
- 14. The result process for the above post code stands closed in all respect except 01 vacancy kept pending under OBC category for verification of candidature.
- 15. Waiting panel was valid for a period of one year from the date of declaration of result i.e. upto 18.11.2021 as per Main Result Notice No. 706 dated 19.11.2020 which



has been expired. The said result is declared against returned dossiers by the User Department which received in the Board well before expiry of waiting panel.

- 16. Mere inclusion of name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.
- 17. The category wise marks obtained by the last selected candidates have been given as under:-

- 18. Kindly note at sub-para-vii of para-2 (Mode of Selection) in the Advertisement No. 04/17, that "If there are two or more candidates in the same category having equal marks in the examination, the candidate older in age will get preference" In case of further tie, candidate having higher marks in Section "A" of the test shall be preferred.
- 19. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any detected at any stage or arising due to court cases., if any.
