Sub: Release of marks for Tier I Exam for the post of Deputy Manager (Traffic) (Post Code - 07/22) in Delhi Transport Corporation (DTC) and shortlisting of candidates for Tier-II Exam

1. The DSSSB vide its advertisement no. 06/22 dated 11/04/2022 with closing date 09/05/2022 had advertised 03 vacancies (UR-02 and OBC-01) for the Post of Deputy Manager (Traffic) under post code 07/22 in Delhi Transport Corporation (DTC).
2. The normalized marks obtained by 8377 candidates who appeared in written examination held on 06/08/2022 and 12/08/2022 has been uploaded on Board's website. Candidate can view their marks by logging into their account in the OARS Module www.dssbsonline.nic.in
3. Based on the performance in Tier-I written examination (online mode), 201 (Two Hundred one) candidates as under have been provisionally shortlisted to appear in Tier II examination subject to correctness of the information furnished by the candidates in their online application forms.

4. The shortlisted candidates shall be called for Tier-II examination separately
5. Since documents have not been called from the candidates along with the application forms as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of names in the list of candidates qualifying for appearing in Tier-II examination does not entitle them any right over the post.
6. Reserved Category candidates who have obtained marks above or equal to the last shortlisted UR Candidates have been shortlisted against UR vacancies and their final selection to the post shall be considered in UR category, subject to availability of vacancies.

7. While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
