Further, the recognition of the universities from which the degree/diploma/certificates have been submitted by the candidates should also be verified. Mere inclusion of name in the result notice does not confer any right upon the candidates over the post.

The user department shall also get the SC/ST/OBC certificates verified from the issuing authority before his appointment. Further, in case of OBC candidates, it may also be verified that the candidate does not belong to the persons/section (Creamy layer) mentioned in column 3 of the Schedule to the Govt. of India, Department of Personnel and Training O.M. No. 36012/22/93-Estt.(SCT) dated 08.09.1993, O.M. No.

36033/3/2004-Estt.(Res) dated 09.03.2004 and O.M. No. 36033/3/2004-Estt.(Res)dated 14.10.2008.

The result has been processed keeping in view the eligibility conditions regarding educational qualifications/CTET, caste certificates etc. as on cut-off date i.e. 20-03-2013.
