Supplementary Result Notice No.- Community Worker, Post Code-60/2012
In Municipal Corporations of Delhi

- 1. DSSSB vide result notice No. 676 dated 26.06.2018 had provisionally selected 49 candidates (UR-30, OBC-10 & SC-09) to the post of Community Worker in MCD under **post** code 60/12.
- 2. User Department i.e. SDMC has returned the dossier of Roll No. 13900016 & 13900164 vide their letter dated 31.05.2019 received on 04.06.2019 after cancelling of the candidature on the ground that candidate has not responded/ joined the post of Community Worker. As the validity of the waitlist panel is up to 25.06.2019 and the two dossiers have been received prior to the expiry of the waitlist panel, the Board is declaring the result of the candidate from the waitlist panel. The vacancy created on cancellation of candidature of candidate having roll number 13900164 has been processed from the waitlist candidate of UR category. None of the candidate available in waitlist panel under OBC category.
- 3. On the basis of one Tier examination held on 21.05.2017 and after preliminary scrutiny of the candidature of candidate on the basis of the documents uploaded in e-dossier as per the provisions of the statutory Recruitment Rules for the post in respect of the educational qualification and the terms and conditions of the advertisement, the following candidate are provisionally selected to the post of Community Worker in SDMC under post code 60/12.

- 5. The selection to the above one candidate shall be further subject to the thorough verification of the candidature of the candidates by the User Department including the identity of the candidate. The selection is purely provisional subject to scrutinizing the experience details furnished by the candidate in reference to the one year essential experience as prescribed in the RRs for the post by the User Department at their own level. DSSSB has not undertaken veracity/ scrutiny of experience certificate being technical in nature and not having details of recognition of Social Organization. User Department may ensure their scrutiny / correctness at its own level before issue of offer of appointment.
- 6. The candidature of the candidate is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules for the post or any other genuine reason. The decision of the user department/ appointing authority regarding the eligibility of the candidate shall be the final and binding on the candidate.
- 7. The Competent Authority of the user department shall arrange to verify the correctness of the information/ documents as furnished in application forms vis-à-vis the original documents including the educational qualification. Further, the appointing authority shall verify these documents and satisfy itself about the authenticity of documents/ certificates before finally appointing the candidate.
- 8. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as laid down in the

recruitment rules and after verification of the correctness of the information / documents as furnished in the application form and e-dossier vis-à-vis the original documents related to education qualification, age and other essential certificate as per instructions issued by Govt. of India vide MHA **OM No. 2/29/54-RRs19-11-54**.

- 9. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
- 10. Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
- 11. The recruitment process for the post of Community Worker stands closed in all respect.
- 12. Further waitlist panel/panel for the post code 60/12 stands expired on 25.06.2019 i.e. after one year from the date of declaration of result on 26.06.2018
- 13. The category-wise marks scored by the last candidate provisionally nominated are as under:-
