SPEAKING ORDER

WHEREAS, the Hon'ble High Court vide order dated 20/03/2026 in WP (c) No. 12220/2025 (GNCTD & Ors. Vs. Ramavtar Dhobi) that *"the Tribunal by way of IO-21, relying on the judgment of Poonam (Supra) allowed the OA filed by the private party. The Government has failed to bring on record any document to highlight that the requisite intimation was indeed sent to the private party. Accordingly, the present petition is dismissed."*

WHAREAS, the Board advertised vide No. 04/2017 dated 20/12/2017 the vacancies for the post of TGT (English), Male under Post Code 131/17 and one tier written examination was conducted on 02/09/2018. In all 367 vacancies were notified, against which 556 candidates were shortlisted. Thereafter, a general notice No.163/PGT(English)Male/Intt.Cell/result/DSSSB/2018-19/277 dated 30/01/2019 was published on the website of the Board informing them that marks list has been uploaded on the website. Further vide said notice, the shortlisted candidates were given the opportunity to upload their documents in the e-dossier module w.e.f. 04/02/2019 to 13/02/2019 with specific direction that if any candidate fails to upload the e-dossier during the above said period, her candidature will be rejected and no further opportunity for uploading e-dossier will be given on whatsoever ground.

WHEREAS, out of a total of 556 candidates shortlisted, 446 candidates have uploaded their documents in response to the said notice and 110 candidates, including Sh. Ramavtar Dhobi have failed to upload their documents.

WHEREAS, the applicant, Ramavtar Dhobi (D.O.B. : 05/08/1990), Roll No. 2650001341, applied under the **SC** category and secured 81.00 marks out of 200 marks in the written Examination. The Cut Off marks is 85.00 in this category.

WHEREAS, in view of the above, the applicant is not falls in consideration zone as Shri Ramavtar Dhobi secured marks (81.00) which is below cut-off marks (85.00), so he is not qualifying for the Post of TGT (English) Male and therefore, as per direction of the Hon'ble High Court the candidatures of Ramavtar Dhobi cannot be considered for nomination against Post Code 131/17.

NOW THEREFORE, this speaking order is issued with the approval of the Competent Authority and in compliance with the directions of the Hon'ble High Court of Delhi vide order dated 20/03/2026 passed in WP (c) No. 12220/2025 and connected matters.
