Supplementary Result Notice No.-1055 Speech therapist, Post Code-03/2014 In H&FW, Govt. of NCT of Delhi

- 1. DSSSB vide result notice No. 361 dated 06.01.2016 had provisionally selected 4 candidates (UR-02, OBC-02) to the post of Speech Therapist in H&FW, GNCTD under **post code 03/14**.
- 1. User Department i.e. H&FW has returned the dossier of Roll No. 12006264 on 02.02.2017 after cancelling of the candidature on the ground that candidate has not responded/joined the post of Speech Therapist. As the validity of the waitlist panel is up to 05.01.2016 and the dossier have been received after the expiry of the waitlist panel hence fresh candidate was not nominated against vacancy created due to returned dossier.
- 2. The Hon'ble High Court vide its order dated 07.08.2020 passed in WPC No. 5083/2020 titled as Govt. of Delhi & Ors V/s Sibi Thomas has directed as under:-
 - "5. However, Keeping in view the fact that Ms. Deepti M, the successful candidate, had informed the medical Superintendent, Lok Nayak Hospital, that she would not be accepting the offer of appointment and would not be joining the post vide letter dated 28th November, 2016 i.e. within one year of declaration of the result on 6th January, 2016, this Court is of the view that the vacancy arose within one year of the declaration of the result. Consequently, in the opinion of this Court, the petitioners should have offered the vacant post to the respondent as the vacancy arose within one year of declaration of the result in accordance with para 11 of the advertisement notice, as extracted in para 5 of the impugned order.
 - 6. Accordingly, the present writ petition and application are dismissed and the order of Central Administrative Tribunal is upheld, albeit on a different ground."
- 4. Now in compliance of order dated 07.08.2020 of Hon'ble High Court of Delhi passed in WPC No. 5083/2020 titled Govt. of NCT of Delhi & Ors V/s Sibi Thomas, the Board is declaring the result of the candidate from the waitlist panel. The vacancy created on cancellation of candidature of candidate having roll number 12006264 has been processed from the waitlist candidate of UR category.
- 5. On the basis of Interview held on 07.08.2014 and after preliminary scrutiny of the candidature of candidate on the basis of the documents as per the provisions of the statutory Recruitment Rules for the post in respect of the educational qualification and the terms and conditions of the advertisement, the following candidate is provisionally selected to the post of Speech Therapist in H&FW department under post code 03/14.

- 7. The selection to the above one candidate shall be further subject to the thorough verification of the candidature of the candidates by the User Department including the identity of the candidate. The candidature of the candidate is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules for the post or any other genuine reason. The decision of the user department/ appointing authority regarding the eligibility of the candidate shall be the final and binding on the candidate.
- 8. The Competent Authority of the user department shall arrange to verify the correctness of the information/ documents as furnished in application forms vis-à-vis the original documents including the educational qualification. Further, the appointing authority shall verify these documents and satisfy itself about the authenticity of documents/ certificates before finally appointing the candidate.
- 9. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as laid down in the recruitment rules and after verification of the correctness of the information / documents as furnished in the application form and e-dossier vis-à-vis the original documents related to education qualification, age and other essential certificate as per instructions issued by Govt. of India vide MHA **OM No. 2/29/54-RRs19-11-54**.
- 10. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
- 11. Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
- 12. The recruitment process for the post of Speech Therapist stands closed in all respect.
- 13. Further waitlist panel/panel for the post code 03/14 stands expired on 05.01.2017 i.e. after one year from the date of declaration of result on 06.01.2016

14. The category-wise marks scored by the last candidate provisionally nominated are as under:-
