## Section Officer (Civil) In Delhi Transport Corporation, Post Code 20/15

- 1. The DSSSB vide its advertisement no. 01/2015 with closing date 26/11/2015 had advertised 06 vacancies (UR-05, OBC-01 including 01 PH/HH) for the Post of Section Officer (Civil) under post code 20/15 in Delhi Transport Corporation. The Board had conducted Tier-I (T) written examination on 04/08/2019 (offline).
- 2. The DSSB vide Result Notice No. 888 dated 23.01.2020 and No. 977 dated 13.03.2020 has provisionally selected 04 & 01 candidates (UR-04, OBC-01) for the post of Section Officer (Civil) under post code 20/15 in Delhi Transport Corporation.
- 3. User department i.e. Delhi Transport Corporation has returned 01 dossier (UR-01) on the ground that candidate has not accepted offer of appointment. The dossier has been returned before the expiry of waitlist panel. Hence the Board is declaring the result of panel/waitlisted candidate as per their merit.
- 4. After preliminary scrutiny of the candidature of the candidate on the basis of documents uploaded/provided in their e-dossier as per provision of the statutory recruitment rules and the terms & conditions of the advertisement, the following candidate is provisionally selected to the post of Section Officer (Civil) under post code 20/15 in Delhi Transport Corporation.

Note: That as per RRs, the essential experience is 'One year experience or one year Training as a Diploma Holder apprentice', since, the working experience is a technical matter therefore, DSSSB has not undertaken the veracity/scrutiny of experience certificate furnished by the candidates as such user department i.e. DTC is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the proposed candidate. The selection is provisional and subject to the satisfaction of user department regarding experience certificate furnished by above candidates.

5. The selection of the above 01 candidate (UR-01) shall be further subject to thorough verification of the candidature of the candidate by the User Department including the identity of the candidate.

- The Selection of the above 01 candidate (UR-01) shall further be subject to 6. genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of the advertisement inviting application and subject to thorough reference their photographs, their identity with to verification of signature/handwriting, etc. on the application form, admission certificate, etc. The Candidature of the above candidates are liable to be cancelled by the user department also, in case the candidates are found not to be fulfilling the terms and conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.
- 7. The User Department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department i.e. Delhi Transport Corporation shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
- 8. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his/her eligibility as laid down in the Recruitment Rules and after verification of the correctness of the information furnished in the application form and the documents related to education qualification, age and other essential certificates as per Government of India instructions issued in this regards vide MHA OM No. 2/29/54-RPS, 19/11/54.
- 9. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
- 10. Mere inclusion of the name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.

- 11. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
- 12. The result is subject to the outcome of the court cases, if any, pending in various courts related to this post.
- 13. The category wise marks scored by the last candidate provisionally nominated are as under:-
